 SUDDEN HAD AN ARREST WARRANT ONE WEEK AFTER COP
 SAW ME. YOU CAN SEE TRIAL (WAITING)? I AM S.I.D. I
 MENTALLY + PHYSICALLY DISABLED AND CARE FOR MY 80 YR OLD
 MENTALLY + PHYSICALLY DISABLED MOTHER KNOWS THIS AS I GOT
 SERIOUS CHARGES DROPPED AGAINST MY BROTHER AT A MEETING WITH
 HIM () I FOUND OUT HE AND MY BROTHER WERE FRIENDS. IN
 APRIL 09, I FORGOT TO PAY A \$30⁰⁰ PAYMENT ON FALSE FINE. MAY 09

MINISTER AND HAD PLANNED ON HOLDING ME
THERE NO MATTER WHAT TO GET DATES AND LIES
ON ALL PAPERWORK AND TO ALL INVOLVED AS THE
ARRESTING OFFICER WHEN HE SAW THE COUNTERFEIT
WARRANT SUPPOSED FROM MAY-09, SAID ON 7-14-09
AND I QUOTE "I'VE NEVER SEEN THIS
WARRANT, IT MUST BE A NEW ONE?" AND SECONDS
