ORDER

The complainant alleged that a superior court judge was biased, should have disqualified himself, and issued improper rulings. The commission reviewed the allegations and found no evidence of ethical misconduct on the part of the judge. The allegations of bias were unsubstantiated. A judge is not required to disqualify himself just because a lawsuit is filed against him, and the commission has no authority to decide whether the judge's legal rulings are improper. The complaint is dismissed pursuant to Rules 16(a) and 23.

puppies. Two months later the judge also put a
mechanic's lien (CV) for foreclosed on
my home and gave that plaintiff everything he
