The complainant alleged that a superior court judge was biased, rude, racist, improperly doubled his bond in anger, and made inappropriate threats. The commission reviewed the allegations, the response from the judge, and the transcript of the hearing and decided to dismiss the complaints with a private advisory letter to the judge regarding Rule 2.8(b) of the Arizona Code of Judicial Conduct, which requires judge to be patient, dignified, and courteous. The complaint is dismissed in accordance with Rules 16(b) and 23.

ON 4.1.2011 DURING A SCHEDULED COURT HEARING, JUDGE _____ ISSUED THREATS IN COURT AGAINST DEFENDANT WHEN HE WAS ADVISED THAT HE HAD UNJUSTLY AND IN ERROR DOUBLED DEFENDANT'S BOND WITHOUT THE VIOLATION OF ANY TERMS OF RELEASE CONDITION OR ANY LAW AND THAT HE HAD FAILED TO JUSTLY AND WITH EQUITY ADDRESS CERTAIN MOTIONS TO DISMISS A CASE FOR RULE 8 VIOLATION, QUASH A BOND REQUIREMENT AND ASSIGN EFFECTIVE COMPETENT COUNSEL. JUDGE _____ APPEARS TO BE A RACIST AND IS TOO HOSTILE PREJUDICIAL AND BIASED TO BE COMPETENT TO BE INVOLVED IN THIS OR ANY OTHER CASE OR TO ACT IN ANY NEUTRAL CAPACITY HENCE SHOULD RECUSE HIMSELF OR BE IMPEACHED. HE OPENLY BRAGGED ABOUT EITHER DEFENDANT OR ANYONE BEING ABLE TO DO ANYTHING ABOUT WHATEVER HE DOES OR HIS CONDUCT AND THAT HE WAS "STILL HERE" AFTER ALL THESE YEARS. DEFENDANT IS CLUELESS ABOUT WHAT HE IS REFERRING TO OR BRAGGING ABOUT AND HE ALSO THREATENED DEFENDANT ON 4.1.2011 THAT HE WAS AND WOULD BE JUDGE ON THIS CASE IN SOME SORT OF ATTEMPT TO HINT DEFENDANT THAT HE COULD OR WOULD RETALIATE AGAINST DEFENDANT IN HAVING TO MAKE ANY DECISION PERTAINING TO THE CASE. SUCH UNNECESSARY THREATS, HOSTILITY AND PATTERN OR BIAS AND PREJUDICE FROM A PERSON WHO IS SUPPOSED TO BE IMPARTIAL AND NEUTRAL IS A SHAME TO THE PROCESS, UNETHICAL AND WRONG. RACISM HAS NO PLACE IN THE COURT BY A JUDICIAL OFFICER NOR DOES CRUEL AND UNUSUAL PUNISHMENT AND EXCESSIVE BAIL WHICH VIOLATES DEFENDANT'S CONSTITUTIONAL RIGHTS. JUDGE _____ SHOULD RETIRE, RECUSE HIMSELF OR BE FIRED.
