ORDER

The complainant alleged that a superior court judge improperly denied several emergency requests.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After thoroughly reviewing all of the information provided by the complainant along with the court record, the members of the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. The commission has no jurisdiction to determine the legal sufficiency of the judge's decisions. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.

kids by not taking her 4 different pain
medications. Stephanie as per CPS had my son
involved in domestic violence when he was only
2 months old, he suffered a fractured skull due
to the mother's ex-boyfriend. The date of this
incident was 4/10/08. There have been several
other cases involving Child protective service. I filed
for an emergency hearing and the judge denied.
The judge never asked if dates and times needed
to be changed for parenting time at the
very least. It has been 2 years since last
hearing. People change jobs move, he didn't
consider that I told him that 4 days prior
the mother called the cops when we tried to
exchange the kids, the mother tried ripping the
kids out of their car seats, putting a
bruise on my sons chest. Stephanie has been
arrested for domestic violence during a previous exchange
report: 09.

Shorty after this ruling my son, who was born
premature, and with severe lung problems was diagnosed with pneumonia and was
in an emergency room and doctors office due to mold, urine bacteria, and mildew in
his mothers dump of an apartment. Great job
