Disposition of Complaint 12-011

ORDER

The complainant alleged that a superior court judge and commissioner improperly kept him in jail on a speeding ticket and another superior court judge manipulated him into thinking his prison sentence would be less than what he ultimately received.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judges engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After reviewing the information provided by the complainant, the commission found no evidence of ethical misconduct and concluded that the judges did not violate the Code in this case. The allegations involve legal issues that were previously considered and dismissed by the commission in 2007 and raised nothing new to justify further investigation. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.
