Disposition of Complaint 19-172

ORDER

September 4, 2019

The Complainant alleged a superior court judge improperly sealed his case records and denied him a lawyer.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Rules 16(a) and 23(a).

Commission members Gus Aragón and Roger D. Barton did not participate in the consideration of this matter.

Copies of this order were distributed to all appropriate persons on September 4, 2019.

To Whom It May Concern, I beg you for help,

My name is [redacted] I was put on trial by AZ Judge [redacted] in [redacted] Az. While being held at [redacted] for which I worked at the time (and one of many conflicts of interest). Dr. [redacted] was providing care after I had taken hallucinogenic drugs and given a psychoactive drug via injection by Dr. [redacted] at my home (I didn't inform him at the time I had taken hallucinogenic drugs just prior) that I had researched ONLINE would erase memories. I was in a childlike state, for some time [redacted] I really cannot be sure. I can remember [redacted] saying it tastes like " [redacted] " and poking Dr. [redacted] in the [redacted] while making [redacted] No legal Counsel, and was asked By Dr. [redacted] if I wanted to be competent, after talking to another Dr. How can you ask someone if they want to be competent for court while in that state and act upon what is said. I had [redacted] Bitcoins at the time. While I was in this mental state, they had me enter into a legal agreement. Where they were to use less than half my bitcoins to set up around the clock supervision of me, and have funds given to my work, etc. They had homes purchased under others names around my home. I know this sounds so paranoid and out there but please dig and you will find supporting facts.

By my estimate a [redacted] I remembered, and came forward to be threatened. When I asked for a lawyer they told me " [redacted] ". Withholding legal Counsel and forced/coerced to take another shot. They held over me an agreement that I had agreed to while out of my mind in a highly suggestable child-like state of mind. While using my money, I have even overheard the Judge saying [redacted] and that continues to be an issue. Well I'm remembering now and they continue to manipulate me over and over, block any avenue of assistance, Call curse words, etc. and they are trying to benefit from my other half of Bitcoins which where to of been cashed in approx. [redacted] ago when they reached a certain value. This cannot be legal. As a Judge, Officer, and other local Gov. Official is involved. It is an ongoing cover-up--Conspiracy to benefit directly or thru people, they have ties with, or an organization such as [redacted] my then and current employer. Which had involvement in many of the judges cases I believe forming a relationship. A good sum of my money was given to [redacted] Judge [redacted] Sealed the records at the time, as I need a finger print clearance card and so I would not stumble upon while my memory impaired, but that purpose is no longer valid. The have sabotaged me by feeding me info as if I remembered my crime I would be held accountable. I was taken advantage of and it's illegal!!! please help. Much More I can write, I know this sounds so strange and bizarre but I swear to be true. Please start looking and you will find facts in support. Some involved trying to cover up what has been done, some with motives of money...But all wrong and inflicting harm.

More Details—

Under the agreement with judge (now state of Az.) I had a modified cochlear implant so that everything I say could be monitored and a camera placed in my eye. Look, I know this sounds so out there and wild already and what I say next is even more out there. However I promise all this is true to the best of my knowledge/memories. Please I beg you to look into this matter and you will uncover the truth and evidence.

When I was in that childlike mental state I made numerous predictions, which have come true. I remember trying to warn the people in the courtroom about the I remember having trouble with his name saying, " " but then got it. They all just laughed about it, as I begged them to watch him. I pleaded saying I would not remember and lots of innocent people were going to die. I also predicted with the same reaction of laughing. I remember I kept calling her " ' because of the spelling of her name. I talked about many shows that are now a reality, but didn't exist back then. I have never claimed to be psychic, but all I said has come true, and had to do with the state I was in. Now Judge sealed the court records but there is no reason to keep them sealed now that I have started remembering. I know my father has a copy of the transcripts. Though I didn't remember these people saw things I said coming true and didn't do anything to stop these horrible acts, and that is the proof that people should be made aware of.

I'm reaching out to you and begging for help, because of the way I have been treated every day. The implant that was to monitor audio from me has also been letting me hear (I'm assuming this) what the people are saying that have been monitoring me. Before I started remembering I honestly thought I was developing schizophrenia as the voices I heard (which is faint and goes in and out) were usually calling me names and putting me down. Some were unfamiliar to me but my sister's voice was also one of them. I would hear " " " " ", etc. numerous times a day on average, and just such negative narratives on what I was doing. This cause much depression, and contemplation on even wanting to end my life as I have worked in for sometime and have seen the struggle this affliction causes, even with medication therapy.

I Started remembering in what I call flashes of memories shortly (within a couple months) of returning from visiting my father in That was in the first part of This is also when I started realizing I was not hearing voices in my head, but rather actual voices. At first I thought they had listening devices planted in my vehicles my house and my place of work; however, one day I had decided to just take off and leave it all behind. As after the instigating, teasing, relentless negative comments every waking moment were driving me to the edge. I had my car loaded up and was down in on my out to when I heard my fathers and Dr. voice pleaded with me to come back home, and that's when they told my it was a device in my head. I would say most if not half the memories I have recovered were due to these people feeding me information. Which is actually cruel as I believe a big part of the agreement was if I could remember what I did wrong.

The biggest point is that going on now these people have called my names, instigated me to anger and then later it sounds like others arrive to witness me full of anger, they are constantly manipulating me, and bringing up my money in very extorting terms. They will pretend it is ending, over and over. Manipulating and torturing me, pure malicious intentional mental torture. This is every hour of every day...please stop and imagine that...and also how gullible someone would be that didn't remember most of what happened. Then to put on top of that all the extortion, and mind games that

my bitcoins/money is going to them, or that they would have control over it. My sister stating over and over that she has done so much and entitled to over half my money. There is so much more to what they have done to me, that I can go on and on.

Please I beg you to look into this and not let these people get away with the crimes they have turned this into, as they try to cover-up and conspire to steal. The way they have treated me during this, calling me names, depriving me of sleep at times, and playing with my mind through their lies and manipulation, has turned this into nothing short of cruel and a truly unusual punishment.

Please contact the following people to confirm some details of story. The case was supposedly sealed but that was for my benefit which they can no longer hide behind. Because it is ongoing and involves the Az Judge and other state/local officials I believe their actions are a criminal conspiracy at this point. They interfered with me so much I had to go out of state just to type this at a store. Ridiculing me the whole way. Co-workers and past co-workers are in the , az. Area.

CEO can confirm as well as COO

Though all of them are trying to cover it up and acting in fear of culpability. This is illegal and please watch the whole video and even if you don't believe please post online. Please Share this needs to end and I'm begging.
