**ORDER**

March 31, 2021

The Complainant alleged a justice of the peace overreacted to his lack of full disclosure and failed to order a prosecuting agency to investigate alleged crimes.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

INFORMATION FROM THE PUBLIC LIBRARY VERIFIES BUT ONLY STATED

THEY ALSO STATED AS FURNITURE DISCARDED THINGS OF WOOD (DRESSER DRAWERS, TABLE AND CHAIRS). INFORMATION FROM THE LIBRARY STATES BED BUGS ONLY STAY WHERE PEOPLE SLEEP BECAUSE THEY ONLY CAT AT NIGHT, EVERY NIGHT, SO EVEN THE SOFA THAT WAS CLAIMED BY THEM FOR ME TO PAY FOR DIDN'T NEED TO BE DISCARDED. I KEPT MY KEY (LOCK HAD BEEN CHANGED) AND GATE CARD (STILL HAVE). I USED THE CARD TO CHECK THEIR GARBAGE TO GET PERSONAL POSSESSIONS LEFT BEHIND (LOCKED OUT). THEN THERE'S THE CLEAN-UP - \$ FOR A STOVE, \$ FOR A TUB AND \$ FOR A CARPET BESIDES THE TRASH BAGS. THESE THINGS MAY BE IN BEDROOM APTS BUT I LIVED IN A STUDIO ( ) WHICH HAS NONE OF THESE THINGS.

THE MAIN MANAGER SIGNED IN THEIR 'FULL DISCLOSURE' AS BEING THE TRUTH UNDER PENALTY OF PERJURY SO I ASK THE QUESTION - IS A LACK OF KNOWLEDGE ON LEGALITY WORSE THAN
