**ORDER**

April 7, 2021

The Complainant alleged a pro tem municipal court judge was biased against her and improperly issued a protective order.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Roger D. Barton and Louis Frank Dominguez did not participate in the consideration of this matter.

Talking about you wanna eat my pussy claiming "you sent it to the wrong person" YOU A WEIRDO". I told her if she had any problems then we could talk and she can come to my house. She never came by, so me and my boyfriend left to get food. I forgot something so we went back to get it, and as my boyfriend was coming out of the house [redacted] was walking with [redacted] when he people it was [redacted] of them name but he is [redacted] that is doing [redacted] and has been dating her since he was [redacted] As my boyfriend is walking to the car he points behind him to signal that there is a group of people and are asking for me. they then start yelling at me walking up to me like they are going to hit me the mom starts recording me and getting in my face with her phone she gets closer so I slap her phone out of her hand I felt threatened because I knew her son is gun owner so I jumped in the car and I got my laser out of my purse. They backed up a little bit but were still arguing calling me and my boyfriend racist names. They then started talking about how I lost my baby, calling me a dyke and other names. I asked if anyone wanted to fight me on [redacted] and they didn't say anything. just kept calling me names so me and my boyfriend [redacted] left.
