**ORDER**

June 27, 2024

The Complainant alleged a superior court juvenile judge is part of a sophisticated conspiracy to take children from their parents and traffic them.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Roger D. Barton, Louis Frank Dominguez, and Regina L. Nassen did not participate in the consideration of this matter.

a horrific motorcycle accident the GPS was involved in coercing and bribing my cousin GPS did not cover it up very well they left a sloppy paper trail did you just show systems law enforcement child welfare agency adoption and foster parent agencies along with all of their third party entities are imposters guilty of domestic terrorism their narcissistic they're demon worse first I've seen it especially in [redacted] and know this I've been informed being that I have a bond to privately investigate my own case along with others there's a place near well the airport a tow yard where near that tow yard they're taking children who've been abducted sexually tortured and they're slaughtering them killing them and then putting their remains on a train that goes through [redacted] where I know in fact a person who is the daughter of a cartel who happens to be my boyfriend's mother it's trafficking children and taking children to be killed by a woman I forget her name but it's [redacted] something from [redacted] anyway the woman on my [redacted] she's friends with this woman and she told me and I recorded it how she enjoys suffocating mice and watching them suffocating guy but in her eyes she meant children this is sick and I will see it to it ends that something is done with the judicial system law enforcement and all their third party entities being [redacted] foundation and I will continue to file and there's about [redacted] individuals the only attorney that helped me was fired by [redacted] she gave me three reasons on record of why then I messaged him and he said he didn't put in a motion to withdraw because of the dissolved relation client attorney relationship that was a lie from this [redacted] she needs to be put into jail she's an imposter and terrorism she causes harm she's a threat to the lives of many people high treason she's guilty of domestic terrorism guilty that carries a death sentence these people need to be handled so we need to know who's going to do something about this and who isn't and the people who are going to turn their cheek and look the other way within just know that those people too I will be adding their names as well [redacted] the presiding judge I have caught and on a live recorded hearing that they put [redacted] name in the minute entry someone mailed that to me when asked for that document at juvenile court they didn't have any records of that only I do because I recorded live if I didn't there would be no evidence. I was told by one who viewed my video across the country that the reason the courts do this is because then those judges are no longer protected by the umbrella policies and that's why they do that cover up conspiracy I'm counting on whoever receives this does something about it I'm expecting a reply if nothing is done and nothing becomes of it I keep track and documents anything and everything all the time when indicated I should and I share this amongst the non-profit organizations against Child welfare agency Judicial systems and law enforcements child welfare all of those of the political community that acts against us that has hijacked our governments in order to Target that people by taking oaths from the [redacted] who is owned by the [redacted] government that is trees and already that's not allowed that's already breaks the Constitution being at the Constitution the Federal Constitution has already been broken this makes the entirety of the American nations lawless and All is fair in Love and War.
