ORDER

The Complainant alleged a superior court judge improperly evicted her.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Barbara Brown and Joseph C. Kreamer did not participate in the consideration of this matter.

The justice of peace and the amended constitution for the member service of my home was violated. I was lied to, miss lead, and for that I need to appeal the judges decision based solely on justice of the peace. I'm asking for the Amended Constitution for service of my home, permission, to reside in the home, and to keep service going as long as I was in training and complying and following all rules.

I was unable to make reasonable accommodations solely because I was training 8 hours every single day without pay, and I worked weekends for at least 4^{1/2} I should be given a opportunity to have a fair opportunity. The program was designed for me to become the best civilian ally in the case of the rent owed I was conducting personal services for the ADA coordinator who is my landlord, and the one that is suing me for rent. I worked from home conducting and participating in services. The landlord was not informative about the policy and all program rules. He controlled the finances and I was to work for him in return for shelter, and was promised a car. I was never sexually invade with but in fact was made to be fact apart of a program that was in fact
