**ORDER**

July 23, 2024

The Complainant alleged improper legal rulings by a superior court judge hearing a family case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Caution! This message was sent from outside your organization.

She is currently in charge of the Family Court. I asked her to help me stop the abuse last year. Unfortunately she denied my request and ever since it's a free-for-all of abuses. From the opposing counsel, from my own lawyers from my soon to be ex-husband and now from Judge

Judge opened the door for even more abuses after she did not find it necessary to honor my requests. One was for an ADA accommodation for alternative filing not through the computer program but my email only to the OC and to the judge. After injuries I cannot get on the computer and join and pay and then get back on the next time. by denying my access to communications they have denied me access to participate and for the years of abuse I've already suffered.

they have all allowed my husband to continue abusing me. In my case I started with Judge again denying my ADA request for reconsideration not to force me to I don't have the money I am out of the country having treatments.

It's the same documentation in my case against Judge

Judge, did deny my rule 6 No reason needed to change my judge One time?

But this seems to be a theme in ALL my interactions with the court. They meant that rule is for everybody but me.

They meant other people could call him by phone on the invitation to Court for ? Again not for me?

When the abuse started I tried to reach the Court Clerk the paperwork says emergency issues sent by ex parte communications can be acknowledged and told to the judge but my refused to do that so it's just been years of devastating abuses and I cannot allow it to continue any longer well All the people in the divorce seem to think it's fine?

Judge could've could've stopped the financial abuse and whichwhich chose not to and it's been another horrific year abused by my husband my judge my lawyers his lawyers my daughter my father everybody please open the complaint against Judge as well Please say see documentation sent about Judge so I don't have to fill your inbox again thank you very much
