**ORDER**

July 30, 2024

The Complainant alleged improper legal rulings by a superior court judge hearing a criminal case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

actual service in time of War or public danger; nor shall any person be subject for the same offence to be  
twice put in jeopardy of life or limb; nor shall be compelled in any criminal case to be a witness against  
himself, nor be deprived of life, liberty, or property, without due process of law; nor shall private property  
be taken for public use, without just compensation.  
I FILED COMPLAINT AGAINST THE SENTENCING JUDGE AS WELL HOWEVER THERE
