**ORDER**

October 8, 2024

The Complainant alleged a justice of the peace erred by vacating a default judgment in small claims court and lifting an injunction in a protective order.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Denise K. Aguilar, Barbara Brown, Louis Frank Dominguez, and Christopher P. Staring did not participate in the consideration of this matter.

I've lived the best way I could, with the hand I was dealt. My mother and father could not care for us. I helped to raise my brothers and sisters, and I raised my children on my own. I am a very strong believer in God. never

even gave me a chance to meet her. I really could have helped her. That's what I do. I enjoyed helping people. I hate to see people sad and suffering. But immediately went on the attack against me. I guess she had been told,

"or something. The first thing she ever said to me was,

"A lot of people in Arizona don't know their neighbors. But she meant it in a bad way. Then she and her son and I got into a heated argument, because I would not let her son, and another teenager in my yard, to get a cat out of my tree. The tree has giant stickers-pointed on it, so I knew it was dangerous to climb. They could have sued me, if the teen boys fell, and got hurt. But, the real reason I did not want her son in my yard, was because, I caught her son, and another boy trying to climb over my wall, but one

of my dogs chased The boys back over the wall. They have hated our dogs ever since. I knew the Teen agers were wanting to break into our cars. I had called Police several times for the neighbors harassing us. An officer told me they wanted my car. I need my car. I can't walk places and take the bus. They continued to harass us, trying to run us out of our home. They also want our home. I finally put up a 2 foot wooden topper fence which is also decorative.

Family had begin to shoot guns trying to frighten us out of our home. My daughters had begged me to put up the fence topper, because, on the left side of our home, where their bedrooms are located, directly in front of a door a lot of men would come and go out of, and they were saying,

Kept trying to peep into their bedroom windows. They had to keep their shades pulled down, and their windows locked, because they were afraid of

Then, I caught him trying to peep in my bedroom window. And at about , he used to ride by our home, and shine a bright large round light into our bedroom windows. I had reported him to the police, but either the

Police would not show up, or when they did, they would only write up a Report, take it back to the Police Station, and then change the Report to reflect that he did not do anything, or that I was the perpetrator. I did talk to Internal Affairs, they swept things under the rug.

I continued to experience much harassment from these neighbors, until finally, again, the Department in [redacted] told me to report matters to the [redacted]. I did. The [redacted] did nothing, I reported matters to other higher officials, but the harassment continued. Finally, after [redacted] son attacked my two dogs with bottle rockets, leaving marks and bruises on them, and they vandalized my property, and kept shooting guns to frighten us out of our home, I filed a small claim against them for what they had done to us. The police last came to our home, after a shooting, saying they were not coming back to my home, because they had not heard any shooting.

Small Claims court was finally held on [redacted] in front of Judge [redacted]. I had had an injunction against harassment on [redacted] and her son, but a judge called me in to court, and took it back from me, saying, "I was shocked."

During The Small Claims Court hearing, with Judge she barely let me and my daughter talk.

To show up in court. He had did most of the harassment, with his mother

telling her son, and boyfriend what to do to us. IT was very obvious, The Judge was one-sided and only listened to what had to say;

IT was very obvious that was lying on The witness stand. (Listen to The Tape. We have a copy. Also, said "

" Therefore, making The Police out of obvious liars, The Police said no gun shots ever occurred. When realized she had made a mistake, she started

lying. The Judge, Judge called her up to her desk, and basically patted her on the back. She knew had lied. We

said nothing, my daughter and I, The next thing I know, an officer walked in, I had been telling The Judge how had been

calling me Bald-headed Bitches, and told me to take my ass back in The house. He talked to me badly, while he was in my own back yard. This is the U.S., and Slavery is over with. Judge looked
