ORDER

September 10, 2024

The Complainant alleged a superior court commissioner was biased in legal rulings against her in a guardianship case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Roger D. Barton, Louis Frank Dominguez, and Christopher P. Staring did not participate in the consideration of this matter.

To whom it may concern:

I am writing to file a formal complaint against _____ regarding
judicial and legal misconduct that became evident to all in court,
including my own representation.

For the record, that was case number _____ .

The prejudice, bias, and wrongful defamation that I have experienced in the
handling of my case, was unwarranted and unjustified, and there was a
consorted group effort to discredit me all along.

I have plenty of our home video footage that captured why such has been the
case, and at this point, it's probably a good thing that my right to an
evidentiary hearing was denied. However, more on that here shortly.

It is unbelievable to me that those whom we entrust to serve justice, are
creating injustices for others instead.

I refuse to accept that, on behalf of those who will never find the
strength and courage they need to be heard, because someone in our judicial
system silenced them like they assumed they have done to me.

For the record, when they silenced my voice, they only reawakened my warrior spirit because as it turns out, it's a no nonsense type of disposition, one which I will now put to use in order to speak louder than ever, in order to make my voice be heard.

That shared, I believe that my rights have been violated, and I have been subjected to a targeted campaign of defamation, improper misconduct by the judge, withholding of exculpatory evidence, emotional harassment, failure to disqualify when the law requires, abuse of authority and power, all of which has had severe consequences for me. I have been the victim of fraudulent misrepresentation of the factual allegations in my case, leading to false accusations and a distorted portrayal of the events that occurred. This has resulted in a denial of my right to speak in court and present evidence in my defense, as well as a denial of my right to an evidentiary hearing to address the false allegations against me.

Furthermore, I have been subjected to direct and indirect implied statements of repercussions from her if I were to exercise my rights to protect my husband, or to call on those who are supposed to be protecting him.

She has cause me a lot of pain, and allowed for others to cause me intentional pain and hurt too because she was dismissive of anything that would show that what others were saying was never true in the first place.

That her pre-existing presumptuous apparent bias against me, a false orchestrated defamatory campaign was allowed to carry over into her courtroom and onto our new case, let's me know that I was targeted, and so does our home video footage.

Let it be known that all of that video footage is now being kept for safe keeping by two other agencies, so any requests for it will have to go directly to them.

It should be noted that the long term damage that has already done to my reputation has caused me emotional distress.

The type of damage that does not align with the judicial principles that we place in our judicial system, especially into the hands of a judge.

I believe that all of her actions, including her gross negligence constitute a violation of my civil rights and have had a significant impact on my life.

I am requesting a thorough investigation into all of the misconduct and prejudice that I have experienced in my case, as well as a review of the actions taken against me.

I am also seeking a thorough investigation against those who participated in the judges misconduct. Let this formal complaint also reflect that I have very damaging evidence of that.

The consorted group efforts which created more emotional harm for me than I could handle which calls for nothing less than that to be included in this investigation.

And since the extremely presumptuous presiding judge denied me of every single right to a fair trial, I am requesting that if she decides to be dismissive of my complaint, that her reasons behind that be thoroughly investigated as well.

My right to a fair trial, my right to speak, my right to an evidentiary hearing. The judge demonstrated bias and prejudice towards me, showed unequal treatment, spewed out untrue statements without worrying about the ramifications for me of her implied words.

Again, for the record, I am fully prepared to show all of the never before seen home video footage that will support everything that I say. Including video footage where those working alongside the judge can be heard telling

my husband that the judge was never going to let me speak, she didn't care I had to say, and that she was only siding with the petitioners, ". Mind you, these are fully grown men who are older than me, and are extremely underhanded and less than credible or noble people. While they may have bamboozled a judge, a court appointed attorney, a court investigator and their own attorney, let this complaint reflect that they cannot bamboozle the eyes that matter the most, cameras!

The same petitioners that the judge made no effort to hide in court that she was only favoring, without facts, and only going on their deliberate, fraudulent, misrepresentation hearsay of the facts.

Video footage like this is extremely important to my case because it shows that my right to tell my story, continue protecting my husband, never stood a chance.

Unfortunately for my vulnerable adult husband, it means that he never stood a chance either!

It's very unfortunate that a miscarriage of justice was allowed to take place when a judge who only demonstrated favoritism for one, and hatred for another, evidently broke all of the rules in her own courtroom.

That type of impetuous misconduct is not only a disservice to me, but to all who have yet to come before her, and those who will probably never have the courage to speak up for themselves.

That's why I'm here!

Because Injustice for one is injustice for all.

Her gross negligence and the lack on impartiality she demonstrated throughout the court hearings is why I have to file this complaint.

It was Martin Luther King Jr., one of our greatest leaders in history who said, "Injustice anywhere is Injustice everywhere".

Judge

set the tone for that type of misconduct to continue to take place.

That said,

I trust that you will take my complaint seriously, and take appropriate action to address the injustices that I have faced. I trust that the misuse and authority that the judge was able to influence others to join in on, will not be something that she will be allowed to do to whomever is in charge of my complaint.

For the record, I have very serious concerns that because the judge already implied in court that " ", that there will be repercussions for me if I exercised my right to protect my husband, or exercised my right for evidence to be heard, that I also stand to be retaliated against for this complaint as well. It should also be noted that she openly encouraged others to take wrongful actions against me without any warranted justification for doing that other than to display her authority and power some more in an open courtroom.

It should also be noted that immediately after she encouraged that, the harassment of what she had encouraged began, something I also have strong evidence of.

If I say more, I'll say less.

I will stand by every single allegation that I make because when the judge failed to allow me my right to show all of the very telling evidence, she also failed to realize that it will now all go to those who are supposed to be looking into her deplorable and disturbing behaviors and actions.

That said, I look forward to a prompt response to this letter, in order to address all of the alarming and disturbing misconduct that the judge allowed to take place, and that she participated in.

Also, VERY IMPORTANT!

Please be advised that at this point, I do not want anyone other than the selected person in charge of overseeing this complaint, to handle any of the links or video footage that my third authorized third party will send.

Unfortunately I had to learn the hard way during court, that my evidence was tampered with when it was forwarded from one person to the next in court.

I absolutely do not wish to go through that again.

Thank you for your help with this undeniable matter of injustice and let this email serve as an official notice of complaint.
