ORDER

The Complainant alleged a superior court judge made improper rulings in a family law matter.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Denise K. Aguilar, Barbara Brown, and Louis Frank Dominguez did not participate in the consideration of this matter.

I have had several hearings with Judge _____ that resulted in not looking at the evidence with a one-sided outcome.

I was denied change of venue favoring the other party stating I can just call into hearings and my witnesses can do the same. All of my daughter's care has been transferred to _____ County to include _____ therapy. Holding the case in _____ County only benefits the party with a DV record and not making it convenient for the victim and my witnesses.

I have stated several times in every hearing the other party has a DV arrest record _____ to include submitting the DV record in court. I was ignored and/or the Judge changed the subject. In this case, there are several documents of evidence of police reports, medical reports of DV, and a video of abuse. It has been a year since his DV arrest record and he continues to have legal decision-making for our child. This makes medical facilities uncomfortable and aware of the lawsuit he caused at another medical facility _____ County Case # _____. I told the courts several times, that the other party impersonated my son's father after the divorce (not his biological father) and was able to obtain medical records of abuse, one of the records that he submitted to the family court. The court ignored fraud including the document I submitted to the court multiple times of the release of information of his signature claiming to be his father and living with him, still ignored.

I filed for temporary orders with notice and served to the other party on _____ and didn't get a response back. I filed a notice of filing as a reminder on _____, no response back. The Revised Arizona of Family Law Procedure effective _____ is supposed to streamline family cases to be heard quicker, and in my case, I was ignored as my daughter's health continues to get worse and now needed a total of _____ medications due to neglect.

In the hearing heard on _____, Judge _____ called me the "problem" in reference to my filing of documents. When the issue in my case is evidence continues to be refused at hearings to favor the other party. I stated false statements made by the other party under oath and having evidence to support my claim and it was ignored multiple times. The judge states he cannot give legal advice. But several minutes later provide legal advice based on false statements of the other party. The judge also included his legal advice on his orders of denial of change of venue. How can this be allowed? Right after the hearing due to the uplifting the other party's false statements, my protection order against the other party was violated with insults and threats that I had to report to the police and explaining this occurring after a hearing. I do not feel safe and continue to be belittled for fighting for my daughter safety and concern.

I have _____ years worth of _____ recorded conversations where they state my concerns need to be heard in family court and my response is the court refuses to look at any evidence involving my child or his arrest record and they deflect by focusing on something random that has nothing to do with the hearing to run out the time with stories of past hearing of others. I have recordings of police officers frustrated and confused by the family courts. This involves violation of the 14th Amendment of Due process of the constitution, and I reported this case to the _____ and gave references of other victims of court hearing that have experienced the same thing. I also preparing to submit my federal lawsuit against the State involving this case.

Why is the state court protecting a person with a DV arrest record and pending fraud charges for lying to the hospital to obtain a minor he shares no biological genes with that he submitted to the family court and ignores the safety of an _____ child?
