The Complainant alleged a superior court commissioner was biased in making improper rulings in a guardianship case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Dear Commissioners,

I was hesitant to file this complaint due to the severe nature of the threats and Retaliation However, I felt it was necessary, considering my family and my life matters and this behavior should not be tolerated.

I am writing to formally request the recusal of Judge _____ from my ongoing case due to numerous instances of _____ misconduct and violations of our constitutional rights. Repugnant behavior such as the use of Threats by utilizing Extortion tactics to force me to give exuberant amounts of money outside my limited retired income for no sound reasons and the THREATS of my removal from my (2) DISABLED children, and issuing "bench warrants" for my arrest When I have Not committed a CRIME and placing me in "JAIL WITH NO BOND, initially put a fiduciary bench warrant out for my arrest, and then canceled the order, and put unreasonable amounts of court fees for me to pay (half of all the attorneys and (4)Fiduciaries, per each court proceeding, when I didn't hire any of these representatives or agents.(in a jokingly manner) the Judge stated she going to squashed the bench warrant because I will have enough trouble digging my way out of the financial hole

that she has ordered me to pay, if I don't carry out these demands “

”and psychological (threatening to harm my reputation) with FALSE Embezzlement charges, THIS IS A CRIME to implement such things on a innocent person. as well as making threats against me and my children, safety or well-being and the selling of my son paid for home/Property. This is unethical behavior, making threats to gain compliance from me through intimidation. I and my son have endured physical duress threats concerning our safety economic and psychological duress threats causing (unnecessary emotional pressure) also the veiled threats pertaining to my parenting stating I'm pathetic, and neglecting my children and how she should Remove (my Son whom is self efficient old non-incapacitated young man from “ ”and sell the property. THIS BEHAVIOR OF INTIMIDATION IS PROHIBITED and shouldn't be displayed in or out of the court room. Also advised that I get my daughter who just turned with to get a job and pay for some bills.

I have been subjected to:

JUDICIAL COERCION

FALSE IMPRISONMENT (to punish)

Unlawful duress

Conditional threats

Indirect threats

Direct threats

Below, I have outlined specific incidents that support my request:

1. ****Threat of Jail and Intimidation****:

- The judge informed me that if I report their unethical conduct to Adult Protective Services, the Attorney General, or the police department, they will have me jailed without bond.
- The judge threatened to sell my son's paid-for home and place him in an alternative home setting, cutting off family members from seeing him.

2. ****Coercion to Fabricate Charges****:

- The judge instructed fiduciaries and attorneys to file false reports of financial exploitation against me to defame my character.
- Despite a previous case being dismissed due to lack of evidence, the judge ordered the re-filing of these reports, stating, “ .”

3. ****False Accusations and Overreach****:

- The judge falsely accused me of abusing my son's Social Security benefits as his payee, without any proof, and recommended Compass take over his benefits.
- The judge coerced (made)my disabled son to “ ” make a mockery of his disability. He has injuries and also is legally This

treatment caused my son cry because he felt humiliated by these actions coming from a judge that if he or I (mom) change the phone number threatening to move him to a private home and sell his house if he did and put me (mom) in JAIL with no bond.

These are the things that we endure in this Judicial proceedings

4. ****Racial Bias and Discrimination****:

- The judge made racially biased statements, suggesting that I might understand a guardian better because we are of the same " , " implying racial solidarity and attempting to influence compliance with her rulings.

1. ****Unfair Financial Burden****: I have been ordered to pay exorbitant attorney fees for representation I did not hire. Failure to pay these fees in a timely manner will result in my imprisonment without bond, which is unjust and punitive.

1. ****Procedural Irregularities****: The judge has deferred her responsibilities to others in the court room proceedings allowing them to decide on charges against me, further illustrating a lack of impartiality and judicial responsibility.

1. ****Violation of Free Speech****: I have been threatened with contempt of court and arrest without probable cause for exercising my First Amendment right to free speech. (I am without representation.) *I was denied counsel by a previous Judge

These actions indicate a severe bias and misconduct, compromising the fairness and integrity of the judicial process. Attached as Exhibit 1 is evidence detailing prior unethical or illegal conduct by the judge, further supporting my request for recusal.

The Due Process Clauses of the United States Constitution mandate that judges recuse themselves from cases where there is a personal financial interest or significant bias. The current proceedings deviate so far from acceptable legal norms that they can no longer be considered fair or just. This constitutes an egregious miscarriage of justice.

The American Bar Association Code of Judicial Conduct requires a judge to recuse themselves when a conflict of interest exists. Given the strong bias and unethical conduct displayed by Judge [Judge's Full Name], her continued involvement in this case is untenable. Failure to recuse should result in sanctions as per state jurisdiction guidelines.

Thank you for your prompt attention to this matter. I trust that you will take the necessary steps to ensure a fair and impartial judicial process.
