ORDER

The Complainant alleged a superior court judge violated her right to be heard and was biased.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Christopher P. Staring did not participate in the consideration of this matter.

I WAS TREATED UNFAIRLY SINCE I FILED THIS SUIT IN _____ THERE WAS ONE HEARING CONFERENCE ALLOWED WHERE _____ ORBID ME TO SPEAK I FILED MULTIPLE REQUESTS FOR A HEARING IN THE LAST _____ YEARS AND WAS DENIED ALL MOTIONS AND REQUESTS. I FILED FACTUAL HARD EVIDENCE PROVING MY CLAIM MULTIPLE TIMES AND MY EVIDENCE WAS DISREGARDED, LOST, NOT FILED BY THE CLERKS AND/OR DESTROYED BY THE CLERKS. I BELIEVE MY CIVIL RIGHTS AND DISABILITY RIGHTS HAVE BEEN VIOLATED BY _____ AND HIS STAFF REPEATEDLY THROUGHOUT THIS CASE PROCESS AND NOW THE APPEAL I FILED. THE CLERKS HAVE PURPOSEFULLY GIVEN INACCURATE INFORMATION AND MISS FILED MULTIPLE FILINGS INCLUDING THE ORDER THAT WAS ALLEGEDLY SENT OUT BY _____ THAT I DID NOT RECEIVE BY MAIL OR EMAIL PREVENTING ME FROM RESPONDING TO SUBMIT MY SUMMARY JUDGMENT AND THE SAME FACTS I ALREADY FILED THREE TIMES BEFORE SINCE THE CASE WAS FILED IN _____ HAS REFUSED TO HEAR MY PLEAS FOR THE NEED OF RELIEF BUT CHOSE TO DENY ME AND BLOCK ME EVERY STEP OF THE WAY INCLUDING FORBIDDING ME TO SPEAK I AM THE ONLY RESIDENT OF MY HOUSE HOLD THAT I WAS BORN IN _____ AND GIFTED BY MY DAD IN _____ THAT I PAY ALL MY UTILITIES, PROPERTY TAXES, INSURANCE, MAINTENANCE, AND CARE FOR MYSELF IN ALL PERSONAL AND BUSINESS MATTERS I AM INDEPENDENT. _____ REFUSES TO SEE HARD DOCUMENTED EVIDENCE OF ABUSE, FORGERY, SLANDER, OUT RIGHT LIES TOLD AND INFLICTED BY THE DEFENDANT. I ONLY FILED THIS CASE DUE TO MALICIOUS HARASSMENT AND THREATS TO MY LIFE BY THE DEFENDANT INCLUDING CLAIMING TO BE MY GUARDIAN, CLAIMING I PAY HER RENT, CLAIMING SHE PAYS MY BILLS, AND AT THE SAME TIME SHE IS TRYING TO SELL MY HOUSE FROM UNDER ME HAS TAKEN OUT MORTGAGES ULTIMATELY MAKING MONEY OFF OF ME ILLEGALLY FOR YEARS AND DISCREDITING ME AS AN INDEPENDENT COMPETENT HUMAN. THE DEFENDANT HAS COST ME THOUSANDS OF DOLLARS IN THE PAST DECADE PLUS BY ESSENTIALLY ASSUMING MY IDENTITY AS THE OWNER OF MY HOUSE AND PROPERTY _____ HAS REWARDED A MURDERING LYING THIEF AND DENIED ME FREEDOM FROM HER FORCED SLAVERY OF MY TITLE TO MY PROPERTY AND LYING THAT I PAY HER RENT AND SHE HAS SOMEHOW GIVEN ME PERMISSION TO BE ON MY OWN PROPERTY BY FORGING MY DEED. HOW CAN A SO CALLED JUDGE BE CONSIDERED LEGITIMATE WHEN BLATENT EVIDENCE HARD EVIDENCE IS CONTINUOUSLY OVERLOOKED AND IGNORED. I HOPE TO SEE _____ AND HIS CLERKS REMOVED FROM ANY POSITION THAT WOULD ALLOW THEM TO INJURE ANY ONE ELSE LIKE I HAVE BEEN INTENTIONALLY INJURED BY THEM. MAY GOD HELP YOU ALL TO SEE THE GRAVE INJUSTICES COMMITTED A GAINST ME BY THE EVIL _____ AND HIS CLERKS. THIS CASE WAS INTENTIONALLY DRAGGED ON TO CLOSE IT ABRUPTLY WITHOUT EVEN NOTIFYING ME- I CALLED IN TO THE CLERKS TO RECEIVE ANY NOTIFICATIONS FROM _____ BY MAIL OR EMAIL. PLEASE REMOVE _____ AS SOON AS POSSIBLE BEFORE OTHERS GET INJURED AND MORE TIME, ENERGY, RESOURCES, AND LIVES ARE LOST. I WOULD NOT BE ALIVE IF IT WAS NOT FOR GOD ALMIGHTY I FILED THIS SUIT TO SAVE MY LIFE I AM A CRIPPLE, SINGLE, INDEPENDENT GIRL. I AM TOO OLD AND CRIPPLED TO SURVIVE BEING HOMELESS. THE DEFENDANT HAS NOTHING TO DO WITH MY LIFE OTHER THAN STEALING MY PROPERTY TITLE ON PAPER _____ DENYING ME JUSTICE AND FREEDOM FROM THIS THIEF IS AN ATTEMPTED MURDER. TERRIBLE TO ENCOUNTER A JUDGE WHO HAS NO REGARD FOR LIFE OR CARE FOR FELLOW HUMANITY.
