**ORDER**

October 18, 2024

The Complainant alleged a superior court judge failed to notify her regarding the court date in a protective order case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Barbara Brown and Christopher P. Staring did not participate in the consideration of this matter.

taking a hammer to our property, and beating down  
a 2 ft. wooden fence I put up between he, and  
myself, vandalism. He knocked the wood down on  
top of my daughter's car, damaging her car, we  
gave him estimates, he fought with me over  
my own fence, (a brick wall, which is mine)  
he brought his family to my home, hollering  
screaming, and cursing, calling me  
names, doing monkey dances at my gate,  
I guess because I purchased the home before  
than did. And \_\_\_\_\_ told me, "  
!!!" and ran from my gate,  
leaving his 2 sons and 2 a daughter-in-law  
calling me \_\_\_\_\_ for no reason,

Drawing a large crowd around our home, as if we had done something wrong.

had his friends to drive around my home on motorcycles, trying to intimidate me, calling my name, loudly, and shooting air rifles to frighten us, and I would also face in front of our home, trying to start a fight with us, and stalking my youngest daughter, and he also had his motorcycle friends driving around our home, trying to intimidate us.

These are some of the reasons why I felt the need to go to the Courts, and ask that an Injunction Against Harassment, be placed on and also his wife, and neighbors who live directly behind us, in an apartment building, naming a her son, age

and boyfriend, whose name we have not been able to get because Police seem to be protecting them, and everything they do against us. This includes myself, I'm age an female, I hold 2 degrees, and I am handicapped. My daughters.

family, and , and his wife, all seem very Racist

against many people. We have been called names.

We have learned through out the years, that if you have problems with harassment, to take it to the Courts, to have a Judge to stop the harassment. I moved here from the State of . They have a great Judicial system. We have even gone to the office twice, and we have made several complaints to the regarding these matters. We have also notified the in , The

Civil Division, and the Criminal Division. I have been in the State of Arizona for years. And, I have never even recieved a ticket.

I have been told by sources, that it is the Police, who have been influenced by the Police, to have my neighbors to harass me. Namely, a Seargent, and a Lieutenant, with the Police Dept. The has their names. I moved to , from

AZ, a suburb of , and where we later found out people were not allowed to live in . So, the harassment began there.

While we lived in AZ, I called Police about times. I had to call Senator [redacted] and I also attempted to put Injunctions Against Harassment on some individuals that harassed us, but the court denied me. I also had to write to their Judicial Conduct office, because it was apparent, the Judges were biased against me. It should still be on file.

I never had a problem with Police, until I moved to Arizona. I knew the Police were calling the Courts, and telling the Judges to not let me win my cases. When I moved to [redacted], I did see a Police drive by my home. Immediately, the harassment started all over again. The neighbors, whom I never got a chance to meet, were told by Police to harass me. Again, I went personally to the [redacted] office, and informed them of the matter. Even about them putting a 6 foot make shift hangmans' noose in my tree. When Police were called, the Police agreed with the neighbor, saying,

The exact harassment I recieved in AZ, is the same exact harassment, I am receiving now. And, my daughters have also been harassed, and they have never been in trouble

with the law. But, they are females. I can no longer ever "Call Police, because a Sergeant said he would no longer send Police to my home, because they did not hear any gun shots. I had called them because of gun shots coming from home. Her son and boyfriend shoot guns a lot. even admitted in Court, (on tape) that they shoot guns in her building all the times. These maneuvers by police, shielding the Perpetrators only emboldens them to do more harassment, such as destruction to my property. The Perpetrators know they will not get into any trouble for it.

So, I am reporting to you, my experiences I have had with the Judicial System. I have gone to the Court System to get Injunctions Against Harassments, to file Small Claim Cases, and finally, to file a law suit. These Claims were against Twin, and wife, and her 4 yr. old son
