The Complainant alleged a justice of the peace was biased in his rulings in protective order proceedings.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Barbara Brown did not participate in the consideration of this matter.

I have not communicated or mentioned the plaintiff listed on order of protection in over _____ years. The plaintiff lives in _____ and I live in _____, and every year I've put an order of protection against the plaintiff with police reports attached that the plaintiff I'm fact has been stalking and harassing me and my children. There was no legal legit bases for this judge to grant an order of protection against me with no evidence just exposing herself by continuously making fake profiles on _____ just to screenshot all my posts when I've never mentioned her name anywhere on my _____, she attached her _____ results on the order of protection in which the judge saw and I've never said anything about her having any _____ it's the other way around hence why I have the police reports and she has nothing but screenshots and nowhere on my _____ which is public do I mention her name, especially when she's blocked on every platform, I filed an Order of protection against the plaintiff through _____ county _____ and was granted to me that same day, the plaintiff was served almost _____ months later _____ through _____ county constable, the county where the plaintiff resides. there was a court date so plaintiff could tell her side of the story at the _____ justice court on _____, the judge in that case dismissed my order of protection because I walked out during court. The last police report from the many many police reports I have against the defendant was _____, hence why my order of protection was granted from showing police reports etc etc to a real judge at the _____ justice court _____. After I walked out of the last court appearance with the plaintiff _____ my kids and I went home, an hour or so later I was then served at home by a _____ constable it was an order of protection that was granted by judge _____ from the plaintiff _____ now having me served and calling the police for any little thing I post on my own _____ page as revenge for having her served with good cause _____. Im very active on my _____ and I made a post that had nothing to do with the plaintiff and That same day _____ after the constable served me, he contacted the plaintiff to let her know I had been served, I looked through the order of protection and was upset

because this judge granted an order of protection against me based on my own [redacted] posts, in which she picked any [redacted] posts that she was guilty about even when I never mentioned her or was talking about her, she printed and gave this judge over [redacted] plus pages of all my [redacted] posts, so who's harassing and stalking who? there was a copy of an email the plaintiff sent to this judge [redacted] as evidence that he clearly didn't look at that was an email from [redacted] Police department letting the plaintiff know there was an investigation against her for identity theft and I'm the victim so [redacted] was investigating her, she added that as evidence when the evidence is in fact is against her naming me as the victim. I also received in the order of protection that the judge saw and granted her driver's license? I mean she gave nothing that would substantiate her reason for an order of protection. After I saw the false evidence and [redacted] plus pages of MY [redacted] posts she had to make a fake profile to get I called [redacted] Police department the same day I was served [redacted], I was told by an officer that the plaintiff was just on my [redacted] page and called to make a complaint, I was furious because the plaintiff has been trying to get me locked up for years on unfounded reports through [redacted] Police department or filing false [redacted] reports which comes up unfounded and nothing she falsely reports works with the police nor [redacted], it got so bad with the plaintiff filing false police and [redacted] reports that the [redacted] Police and [redacted] in [redacted] county will not follow up on her reports or even contact me because they know she's a pathological liar and it wastes their time and I could file a lawsuit on the police and [redacted] for harassment due to false reporting the plaintiff makes, [redacted] police is also aware as well, she couldn't get me locked up any other time, so now that I've been served she's back harassing me telling the police I'm on my own [redacted] page talking about her when once again nothing I talk about on [redacted] is about her and this incompetent judge who granted the plaintiff this false order of protection has now put my life in danger because he granted this order to a known shoplifter and psychopath who's using this order of protection only as revenge not for protection in which the plaintiff never needed protection to begin with because cause I don't bother her and there's no police reports of me harassing her in anyway but I have numerous police reports against her since [redacted] most recent was [redacted] the day I was served for the plaintiff stalking my [redacted] page then falsely police reporting I'm talking about her on [redacted]. This judge's incompetence without using common sense to see the plaintiff had no evidence has me once again in a dangerous situation and I'm a single mother who works. The plaintiff religiously checks my [redacted] page everyday all day to see if I'm talking about her, then she tries to file false police reports even when she knows I don't ever talk about her and I have kids, the plaintiff is a liar, she's very manipulative using the courts for revenge against me. Lastly I filed court documents through email to the [redacted] Justice Court [redacted] and attached I requested a telephonic appearance to this judge [redacted] due to no reliable transportation and filed paperwork to request the order of protection falsely put against me be dismissed to the courts where the plaintiff filed, the Judge for the [redacted] Justice Courts is Judge [redacted] and due to the plaintiff harassing this judge with false complaints even tried to get him fired for allegations of this judge having relations with a court clerk which was also unfounded, Judge [redacted] who's the only judge presiding at the [redacted] Justice Court will not see the plaintiff for any reason so that's why judge [redacted] who's a [redacted] justice court judge had to see the plaintiff I'm guessing through video to have false order of protection granted. So today [redacted] I received signed order from a court clerk from the [redacted] Justice Court through email from judge [redacted] giving me a date to appear to request the OOP be dismissed and this judge [redacted] dismissed my request to appear telephonically requiring me to appear in person when I've already stated in my court documents when requesting a hearing I had no reliable transportation and the plaintiff [redacted] is dangerous meaning if I cough

because of this false OOP she'll call the police and this judge is biased and my rights have been violated. I'm the victim of all of this and this needs to be investigated. The purpose of a Protective Order is to restrain a person from committing an act of harassment or domestic violence against another person or persons, and the plaintiff did not prove her case, she perjured herself to the courts and the judge did not use common sense to see there was no evidence. Order of Protection An Order of Protection (A.R.S. 13-3602) is a court order to seek protection from a person you live with, now or in the past, or is an immediate family member. Examples of a requested Order of Protection would be filed against:

Your current or former spouse

Someone with whom you live or have lived

Someone with whom you are having a romantic or sexual relationship

One party pregnant by the other party or someone with whom you have a child in common

Your relative, or your current spouse's relative (contact the Court for specific relatives)

One of the parties is a parent, grandparent, in-law or sibling. None of those apply. And an order of protection also. Ive never contacted her, she's contacted me hence why I was granted an order of protection against her through the justice court and her false evidence she gave this judge is all my posts which is all for entertainment but no posts mention her name EXCEPT one that's it. There's no police reports against me that would say I'm harassing her yet I have dozens of police reports against her most recent . Not only did judge grant this order of protection on false pretenses not looking at evidence but is forcing me to appear in person after I've written this judge to request telephonic appearance due to how mentally ill this plaintiff is, using this false order of protection for her own sick benefit only for revenge that's it. judge needs to be looked into and I do have evidence of the false order of protection against me with the fake and old evidence that has nothing to do with the plaintiff yet her order was granted as well as the motion and letter to appear in person I sent the courts to send to this judge which he denied. This judge is incompetent and has violated my rights

- Prohibits a person from coming near a home, work site, school, or other locations listed on the court order
- Prohibits a person from contacting you by phone, email, text, mail, or other means listed on the court order
- Provides you with legal recourse if the person who is served violates the order
