ORDER

The Complainant alleged a municipal court judge improperly denied his ability to virtually participate in a civil traffic hearing.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Regina L. Nassen did not participate in the consideration of this matter.

I had a hearing with Judge [] for an illegal Right hand Turn which wasn't illegal it for turning into number one lane instead of number two which isn't illegal if there are lane restrictions ie intersection crosswalk work zone the markings on the ground are pretty self explanatory so making a right hand to make a pretty immediate left with no lane restrictions off a side street I can pull into the clear lane all this is now pretty much a mute point I'm just giving you a quick back ground of the situation so there's a clear understanding of why this is intentional and with ill intent . So on [] I had a hearing with [] which had already been postponed due to officer unable to attend That morning my wife's vehicle would not start I had found the out that The [] Court had mandated Civil Traffic be done remote with this in mind I immediately called [] City Court to let them know I needed to appear telephonically which graciously the Judge responded quickly and with the appropriate information for me to call in for my hearing which I very much appreciated. I waited in the que for some time Honorable Judge [] came to briefly tell me that I was live and would be up soon Honorable Judge [] was gracious and very respectful and had seemed fair which made me feel at ease. It wasn't until I went on the live feed where I could hear the Judge asking an officer if he had [] and I could hear someone ask if I was in the building then the microphone went mute 15 or so minutes later the Judge came back on Swore in the Officer which was [] then the Judge turned to me and said it's against the rules and was not allowed for me to appear telephonic for civil traffic which was a complete lie that unfairly interfered with my Judicial Due Process which I feel is a violation of my rights and misconduct on the Judges part the reason this is so important is that the Judge knew I had car trouble and this ticket in question was also tied to a civil rights violation and police brutality by that officer [] he lied in his police report and said he wasn't the pulling over officer to get rid of his body cam to hide his police brutality I was then found responsible 5 days later because I had a hearing at [] Court to quash a warrant that was issued in the same case for resistance arrest from [] traffic stop. I then Ordered the audio transcription confirm my suspicions The [] lied to me at the request of the officer which I feel is a violation of my Rights and My Due Process. I believe that the Judge committed Judicial misconduct there's one place that it's a crime to lie in and that the court in session and the Judge has to set the same standards and be the example. This and the handling of my rights and me as a victim of police brutality has shaken my confidence and my ability to trust the system and I'm ashamed at my leaders who have turn their cheek to this and I hope you great women and men will be the first step in righting a severe injustice and set the example for the rest of the men and women who have intentionally turned a cheek because of who I am and who Officer [] is. I please ask you to help me have the videos of [] assaulting me and committing perjury in his reports and misconduct about his role in this matter
