ORDER

November 22, 2024

The Complainant alleged a superior court commissioner failed to consider supplemental evidence in a probate case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Joseph C. Kreamer did not participate in the consideration of this matter.

I filed a motion 60 after discovering that the opposing party in a law suit hired a PI to social engineer me into hiring their colleague Attorney _____ to represent me, and that their PI met me under false pretenses, seduced me, pretended to be my boyfriend throughout the discovery process and hacked my phone and computer in order to get information for the opposing party to use against me. I also discovered that my own lawyer submitted an _____ report that was not the report they had me review months prior and was full of false information that claimed a police investigation occurred when one never did. There were several other things that I highlighted in terms of new evidence, misconduct and misrepresentation as well.

I then filed a Reply to the Objectors Response in Support of my motion and attached evidence in exhibits A-J, which was likley around 50+ pages of public records and evidence.

The judge made a ruling and only referred to the initial motion I filed with no mention of my supporting Reply, and she denied my motion claiming there was no evidence. I don't understand how a judge could claim no evidence when there was clear evidence and public records to support all of my allegations. Are the Commissioners and Judges not required to review evidence or was this an oversight and the Commissioner didn't read the Reply in support of Motion with all of the attached evidence?

I submitted pages of false information from the _____ report and provided the real police reports the report claimed were investigations into my mom's abuse and exploitation, and proved without a doubt that these police reports were not any investigation regarding my mother's abuse. The police never investigated.

I also provided a document that the opposing party filed with the _____ taking ownership of my mom's LLC that owns her property while she was completely incapacitated. I obtained this document directly from the _____ who time stamped and dated it's recording on the top of the page. The employee at the _____ told me the document made the opposing party an employee, but it really made them owners. My lawyer never explained this and this new evidence prove my mother was abused and exploited. I also provided the medical records that show my mom couldn't bathe and wasn't eating and had been suffering _____ for months. Which showed my mother was being neglected by her caretaker while her caretaker was having my mom sign away her assets.

These are just a few examples of the evidence I provided to support my motion.

I asked that the articles of evidence both lawyers submitted to the court be released. The judge not only claimed I provided no evidence, but denied releasing any evidence that exists by denying any way for me to retrieve such evidence. I don't understand why it is a secret what the attorneys submitted to the court. My attorneys denied to provide this information to me when I asked multiple times, and the judge refused to release it. How would anyone know if fraud or misrepresentation was occurring if the court keeps the attorney's submissions secret?

I also don't understand how a judge can decide whether or not I am under emotional duress. My lawyer billed me for more money than I earned in the entire year. I thought I was pregnant with the opposing

parties private investigator's child. I didn't know he was a PI, and he is not licensed to be a PI. I thought I met a handsome man that loved me. However, once I figured it out and confronted him, he did not deny it, but threatened me with the opposing parties lawyers. In addition, I was diagnosed in with a _____ in my _____ and was told I needed surgery and might have _____ myself- it was a perfect storm.

Perhaps Commissioner _____ is devoid of empathy, but if your mother randomly lost her mind on hallucinogenic drugs and her caretaker was intentionally instigating arguments between you and her then neglected your mom to the point of death, canceling all of her life preserving treatments once she obtained her property, then tried to hide your moms death in order to take all her assets without you knowing... and imagine you are an only child with your mom being your only close family and best friend your entire life... Then these people when caught trying to hide your mom's death claim your mom did this on purpose because you lied about being molested when you were _____ years old... Which I never lied about anything like that. They contest you in court when you bring the will your mom gave you less than a year before her death, and then they start literally lying under oath creating motions claiming you are mentally ill and have substance abuse problems, with nothing at all to substantiate such allegations. At the same time they hired a criminal who actually has been stalking you since _____ when your mom was first diagnosed with a terminal illness and was also petitioned by the mental health court. This guy for _____ years stalks you online and tries to pull scams on you. He hires people to come to your house and pretend to be customers of your business to gather intel. I'm not a lawyer. I thought I did an okay job providing evidence of my allegations, but I don't think it was even reviewed. Is this standard operating procedure of the probate courts? I feel like this needs to be brought to the general public's attention, that your parents can be abused, exploited and killed and it appears it's easy to get away with it. I can't believe the lackadaisical attitude I have witnessed regarding such a horriic event by all of the departments of the state that we trust to uphold the laws and protect vulnerable people. Clearly no one that is supposed to care, cares. If _____ isn't making egregious mistakes throughout their reports, then it seems the judge also isn't reviewing the evidence. To make matters worse, their PI told me that the people he works for are bad people and trick people out of their property and that the _____ is attaining millions of dollars in property across Arizona. My mom was one of many victims. The opposing party referred my mom to a lawyer that scammed her out of _____ before she even died- the probable court empowers criminals.
