**ORDER**

December 17, 2024

The Complainant alleged a justice of the peace improperly failed to hold a protective order hearing within 10 days.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Louis Frank Dominguez did not participate in the consideration of this matter.

Judge at County Court is refusing to provide me a fair hearing or any hearing in general to contest a fraudulent protective order within business days of my request to the court to contest it on Under County law, I am entitled within business days to contest this fraudulent protective order illegally filed on me. I was illegally served on and had to call County Courthouse - they had me sign a form to say I was served on I immediately requested a court hearing to contest this fraudulent protective order against me on and then again on since I received no response. A court date was sent on a month in ~~which is illegal~~ which is illegal. One day prior to the court hearing date on the judge let reschedule less than a day prior to the hearing due to her "traveling." See my evidence for the hearing on which never occured due to the motion to continue being accepted. The judge said he would also hear my case of harrament of injuction on on which is also days past.

  - c. P = Plaintiff and D = Defendant
2. Video/audio exhibits must be uploaded to YouTube with the link to the exhibit(s) emailed to the court at
3. Video/audio exhibits that require plugins or downloads may not be considered.

### HOW TO SUBMIT YOUR EXHIBITS

1. All exhibits must be submitted in person, US mail or via the outside drop box. Please contact the court to confirm receipt of exhibits.
2. All exhibits **MUST** be submitted at least **48 HOURS PRIOR** to your hearing and properly marked. Exhibits submitted later than 48 hours prior to your hearing may be accepted at the Judge's discretion.
3. Once your exhibits are received, the court will send them to the opposing party.

**Documents submitted via e-mail will not be considered.**

**Submitting an exhibit to court does not automatically mean it is admitted as evidence.  
It will still need to be presented at the time of your proceeding.**
