ORDER

The Complainant alleged a superior court judge is corrupt and biased raising concerns of fairness and impartiality.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. In particular the Commission notes that the case in which the judicial officer was alleged to have presided over a family member's case, that matter was transferred to another county several months before the judicial officer was even appointed to the bench. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Michael J. Brown and Christopher P. Staring did not participate in the consideration of this matter.

**CORRUPT, BIAS, RACIST, CHILD
ABUSER**

Hello,

I am writing to formally express my deep concerns regarding the conduct and potential bias of Judge _____ who has displayed corrupt, bias, and racist conduct in the _____ County Courts.

The following instances have raised notable concerns about fairness and impartiality in this case:

1. Judge _____ Corruption in Presiding Over Her OWN Case Who Lived With Her

It has come to our attention that Judge _____ is presiding over a case involving her own _____. Public records suggest that they have lived at the same address. Additionally, her _____ attorney in that case appears to be a personal friend of Judge _____, _____ based on their interactions on social media. Notably, this attorney does not even specialize in family law, raising further concerns about potential conflicts of interest and the fairness of Judge _____ judicial conduct. This is a major conflict and completely corrupt. During the time that _____ was living with _____, she had multiple warrants for her arrest. That means _____, as a public official, was harboring a criminal with known warrants in her home. (**Case Number _____**)

2. Judge _____ gave unsupervised custody to a father indicted in for child molestation

In _____, Judge _____ gave unsupervised custody to _____ an indicted child molester who sexually abused his own children in _____ which is set for trial in _____. **See case number _____** previously lost all custody of his children, until Judge _____ got on the case and gave him unsupervised visitation at the suggestion of _____, a _____ County Therapist with a police report of his own for masturbating in front of a minor during one of his sessions. Also, **see article on _____**

3. Judge _____ gave full custody to an abusive father and had the protective mother arrested for traveling out of state

Judge _____ removed a child from the custody of a protective mother to give full custody to an abusive father, _____ Police Officer _____. You can view the documented abuse on _____

On this channel, he is seen screaming, yelling, throwing hot food on the toddler, bruises from him on the mother, and manhandling both mother and minor. There are documented police reports on _____ yet Judge _____ took the child from mother completely to give the minor to Officer _____ **See case number _____**

4. Judge [redacted] Forced a Party to Come to Court Pro Se. Don't we have a constitutional right to counsel?

In a case where a mother had to let go of her counsel, she asked Judge [redacted] for a short continuance before a trial, instead Judge [redacted] forced her into court pro se without any representation. **See case number [redacted]**

The examples highlighted above are only a few of the many actions that have led me to question Judge [redacted] impartiality, corruption, practice as an officer of the court, and ability (or lack of) to rule over such serious matters of the lives of citizens in [redacted] County. The repeated refusal to acknowledge conflicts of interest, continued bias, and corruption in plain sight have created a situation where justice seems unattainable. There is zero focus on the best interest of children which is the core of family court. Instead, Judge [redacted] favors abusive parents and put these children in harm's way, and punishes protective parents who want to seek justice for their innocent children.

I have attached additional documentation for you to look over in support of my points.

I respectfully request that you review the handling of Judge [redacted] cases and take appropriate action to ensure that the judicial process is fair and just for all parties involved. I appreciate your attention to this matter.

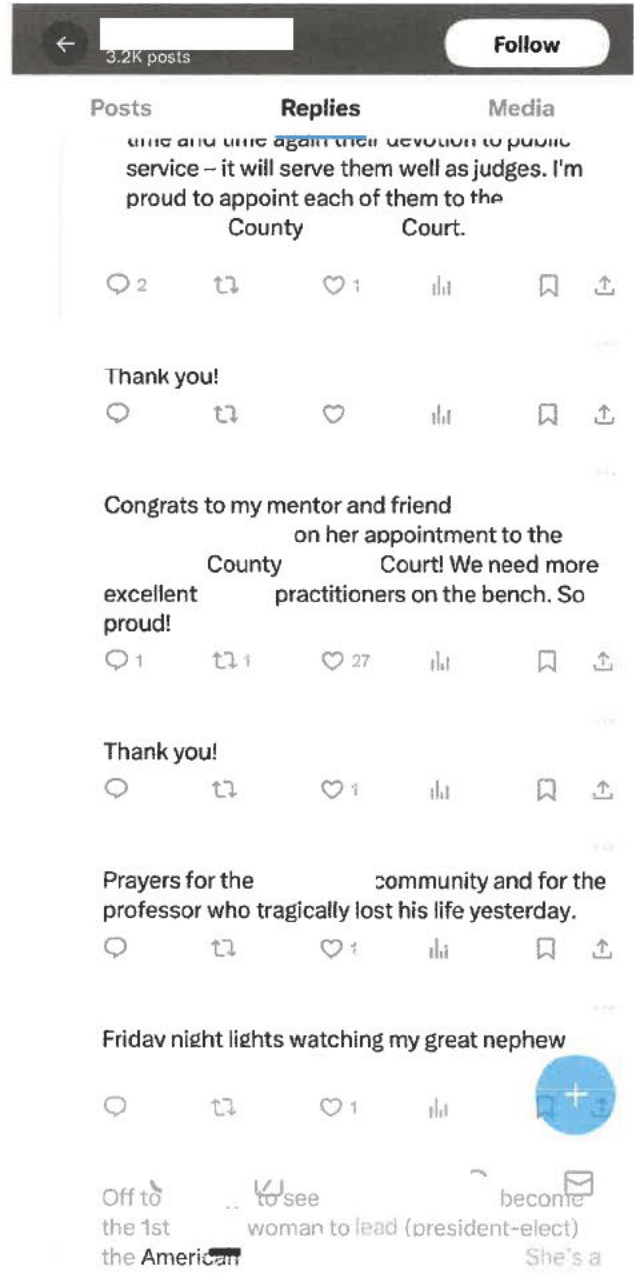
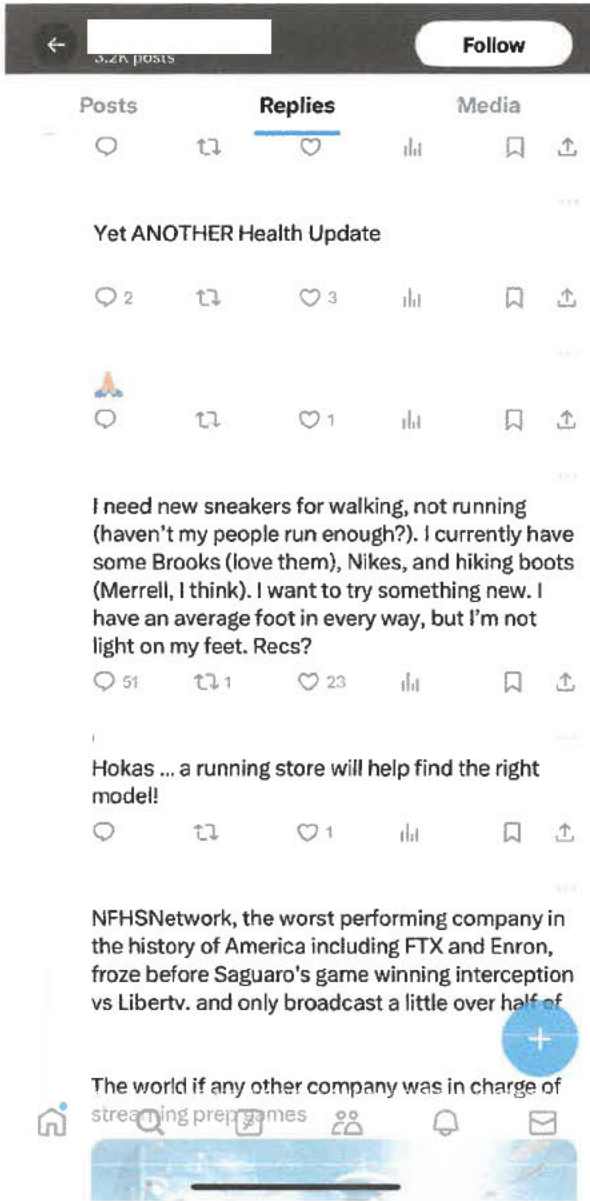
