**ORDER**

January 24, 2025

The Complainant alleged being unfairly prosecuted in a criminal matter before a justice of the peace.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Christopher P. Staring did not participate in the consideration of this matter.

Copies of this order were distributed to all appropriate persons on January 24, 2025.

My name is , born on . I am writing to request your assistance regarding an ongoing situation that has profoundly affected my life taking not only a significant financial that is left me bankrupt, but even more so over egregious and continuing attempts, violating my civil rights repeatedly as well as stomping on my victim bill of rights for what you will find out I was before I was ever made a perpetrator, in fact, was made to be after the failure to act on behalf of the sheriff office and the county attorneys office for who I reached out for help for personally for which was denied, which allowed these crimes to continue, which is the exact reason for that they are on now. Suppressing every bit of evidence from me reaching out prior then not a single thing has been mentioned nor have I ever received one single phone call from one entity of those offices to ask questions to find out or see my life going after this most egregious heinous act that the perpetrators for which the overwhelming evidence is clear has never been so much as brought a charge against them From disorderly conduct charge from was not charge until days before after I was told that the court had dismissed it due to no information which took them months to finally send something stems to where I was never mentioned by name or by the person to claim a crime was even committed to the initial police report As a victim of various crimes,

which my rights have been beyond violated, as well as my victim bill of rights aside from my constitutional including:

- **Assault**
- **Identity Theft**
- **Fraud**
- **Destruction of Property**
- **Mishandling and Loss of my Brother** Cremated Remains

I find myself in desperate need of help. However, it is not the perpetrators I'm seeking justice from at this moment; it is from the people who are supposed to be delivering it.

- **Details:** The case has sat on a court docket for over days related to an alleged disorderly conduct charge that never occurred.

- **Police Report Issues:**
- **Details:** The police report fails to clearly mention any crime or provide substantial evidence of wrongdoing, indicating potential overreach and violation of my rights.

- **Residency and Travel Concerns:**

- **Location:** I reside in .
- **Travel:** Forced to travel to Arizona for court dates, incurring significant financial and work-related burdens, after I had already done so at my last court date for which I had asked the court days before having scheduled time off at work having to borrow money for the overwhelming financial burden as well as maintaining a vehicle to make it which I had done so but was never even told about the change which made my entire trip uneventful even though I've been waiting for this moment for months, which is the only justice I felt I would ever see or get even after my original conference hearing. I also also took the Time from work to be available only to be told a certain time once again confirming it with the court, which was at when the phone call came in shortly minutes before the whole process was conducted on a voicemail for my company to hear Caused overwhelming repercussions every attempt for me to stand up for the very same rights that have been trampled on every single day. I've never felt a citizen of the United States of America, my rights to be violated in such a way that I would actually have to contact the numerous entities in which I did .

I literally had to reach out to the attorney general of Arizona because a judicial officer of the court of Arizona took a personal vendetta against me for not signing the most egregious plea agreement that was more false than the sincere question would be asked was any investigation ever done to include what was included in the plea agreement for which was written and offered before the very first court date after the arraignment Once again over days, the single thing had changed until I filed the complaint with the of Arizona, That is overwhelming that there could be no coincidence of all these events having no connection that the series of events play out like this

I was arrested on with my fiancé at the time who we plan to get married on , for which this case in fact played overwhelming significance in preventing that with the venue already purchased for everything to be canceled,

I was traveling alone in my vehicle in route to a call with PD as my job is operation manager solely responsible for the and county medical Examiner cases intake outtake.

My fiancé question and harassed for which she had asked on multiple occasions which is reiterated by the deputy himself, which clearly states that she was not upset when they had made contact, but only began to get upset only after according to the deputies own remarks stating that it was not anything that I had done or anybody else had done for which led to her being upset for what she did not begin to get upset until the deputy had made contact

according to his own statement, that it was infected deputy, and not myself that made her upset.

Even with that being the case, I would like it noted for the record that my name was never even mentioned by anybody nor suggesting a crime occurred, which the exact statement verbatim written in the police report was “

” Switch to deputies continued the barrage of interrogations, even though myself, nor her had committed any crime we were not permitted to go for which they continue the garage for which she had to ask again I wanna go home for once again still not being allowed to leave, which was a violation of her rights as well as an attempt to get something that clearly Coercion Because if something did take place, she wouldn't have had to say she wanted to go home, but I sat detained from my job which I ended up losing in a hot patrol car in the middle of the , Arizona summer with no air-conditioning and no window for which I asked the officer to please go down the window Heckling gestures of laughing was what these law enforcement officers showed in their professionalism telling me the window is down, there would be nobody who knew how hot it would be in the back of that car more than those deputies themselves, which was done as cruel and unusual punishment, and in fact on purpose, for which I had not committed a crime, I had not been suspected of a crime and the witness that they were claiming to make did not say anything about me whatsoever to ever put me in the backseat of a car in the middle of the summer when I very welcome sat on the curb or stayed in my vehicle, which should've been my right since I had not committed any crime

Also filed a civil rights complaint with the Arizona Attorney General's office in regards to the many numerous violations from the day. I was arrested being in jail for everything that's happened in the following months, bringing significant repercussions, as well as losing my position as the investigator at the county medical examiners office in the very beginning when this was originally brought after I was told it would be dismissed. No information was given nearly months later I finally received a letter in the mail days before , informing me that the case that was in fact told was being thrown out was in fact being reopened, even though I had committed crime, and my fiancé had never even mentioned my name even ever happened.

I would like to note for the record to show characteristics as to as I discovered what was happening for their never to be a single issue of disorderly behavior on my part before, even though I continue to discover countless things as they went on, never once having an issue Nor after that on that day, the police arrest me even though there was no ground so .

Then for in the county attorneys office the very same office I had reached out to for help before my name was on any court docket anywhere never to receive any, but in fact, become a defendant in one of their cases, even though I was the original victim, so which they ignored Which is the reason to deflect Notion that I was a victim for which they violated my victim bill rights Countless event after event after event will clearly show the way this case was conducted how many many numerous times of violations of the law on the police in the county attorneys office even the simplest charge for which I was not guilty of disorderly conduct clearly those violations were more egregious than anything else

And also to note on the record that even though my name was never even mentions as a suspect or even in conversation, the police felt they had grounds to arrest me then also reassuring with the statement was nothing except we just wanna go home for which we were not allowed to which once again violated another constitutional right in order to move freely.

-being stopped entertained without cause, even after it was clear that there was a misunderstanding and

misinformation I was still held, although there was no right to hold her for which we should've been on our way.

-countless times she had to ask to be able to leave, even though she was not being charged with the crime or any crime had been committed. It seems like they were bent on trying to make one for which I was held, and she was held not allowing us to move freely on our way violated once again.

-and if there was any more ways, we could violate those civil rights placing me in a hot vehicle with no air definitely and I could state from fact was cruel and unusual punishment And then being heckled and mocked and laughed about it.

-never being read my Miranda rights after I was placed in the vehicle after about an hour and a half of sitting in the back of the patrol car in the hot Arizona sun I was finally told that they were taking me to jail on this sort of conduct charges for even though I've never been mentioned or crime ever suggested was committed. I was kidnapped and brought to a place even though I committed no crime.

-when I was released on my own reconnaissance when the information given at the hearing, I had to get clarification from the deputy as to who was the person that I was not supposed to speak to That itself shows the level of confusion.

-the exact police report which is the grounds for which they violated my rights and felt they had caused to detain and interrupt my life as a human being and responsibilities I have including my job and my family that does their grounds and Legle cause for doing the things they did has so many discrepancies that are not even just slightly off but overwhelmingly fictions suggesting and making a statement about apple, picking even though there wasn't a single apple to be found inside the car with evidence submitted below we were on our way to to the taste of in that was planned months in advance, backed up and Exhibit 15 below.

Because of the courts actions and attempts to string this out to intimidate me signing a plea, for which I informed her from our very first conversation that I would never be signing any plea deal, for I did not commit any crime, and in fact was very disheartened the fact that I had asked her for help before her, bringing any kind of charge, which no help was given until this day in regards to any of the astounding crimes that were committed against me that a single investigation had taken . but the overwhelming attempts to suppress as well as remove the different entities in which originated is clear and noted on the record from herself to ask the court for another contact her anymore what she knew that was what I was originally had done prior to her, making me a false perpetrator

What has done to me personally leads me to be very weary about her cases that she's had in the past for this is not an isolated incident and her personal dealings with my case or also alarming, which has been evident from the very beginning.

- **Reality:** all along by claiming no knowledge or anything to do with those charges they had went on for months before coming to an end, but it was late when I received that check roughly out of only because had said, she authorized those payments now that she would have to be responsible for them but told me from the beginning she told me she had no knowledge but she when she was responsible to pay she now remembered authorizing them.

- **Financial Loss:** there would be multiple incident totaling close to respectively

- **Claim:** over a month period my direct deposit was used to pay the bills including the mortgage what ultimately bring to light my whole purpose and reason for being.

- **Reality:** I would like this to be the main event for which would be the whole reason for all the things that would occur. While all this Taking Pl., was working in case through the court system of Arizona for felony DUI and four council child endangerment for what she was caught ordered to stay away from his house, and his children never revealed to me until months later, he broke the law, taking his children at times he was court ordered
