ORDER

The Complainant alleged a justice of the peace made improper rulings, muted the microphone, and did not offer ADA accommodations in a protective order.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Regina L. Nassen did not participate in the consideration of this matter.

I have the right to a fair trial. This was not fair.
The judge treated me with derision, repeatedly muting me, threatening me, and refusing to let me answer. I am [], and the judge refused any ADA accommodations, and kept blaming me for " [], when often I did not even know he was speaking.
I did not receive any copies of the documents [] presented.
I have no idea of what most of [] was talking about: I most certainly did not write " []. These allegations are false.
On [] I wrote on [] door a message to law enforcement in case they should find me dead. [] continued to have me live with him and rape me daily (*daily when I was in the [], which was 90 per cent of my time.)
On [] when [] went to the doctor with me and heard from the doctor in person the my [] was [] and [] went on a campaign to discredit and defame me.
I agreed to move out, but needed my wallet and phone returned. [] returned my phone (but wiped of all data), and kept my wallet.
All the items I removed from [] home were mine. I asked for help moving, as I already [] from all the rapes. As I required help with moving, the people who helped me accidentally took some of [] things. When I attempted to return them, [] called his [] friends.
I DID inform [] of the constant sexual assault, but since they were [] friend,s [] rangers refused to take any rape report from me. I asked [] and [] police and Sheriffs, they also refused because [] had jurisdiction.,.
By the time I was inspected in [], it was too late for a rape kit.
I did not " []
I did not " []
[] had all his female friends destroy all my belongings at the library on []. Attached: photos and report.
I did not " []. In fact, I tried to arrange to return the items I purchased for his kids.'
the fact that [] took all my ID and actually charged my credit cards is a pretty large reason to contact the person.I also wanted to know what [] wanted done with the baby. those are quite legitimate reasons to contact someone. [] claims he wants ot be a parent, but has zero access to his children, and clearly had no concern about our baby.
I have no intention of ever talking to [] again. I do not live there anymore as [] made sure I was fired from every job. So a protection order is simply labeling me as the criminal, and letting the greater time of constant grooming and rape, be unpunished.
Having a court order against me gives me a criminal record I do not deserve and further prohibits me form employment.

most likely staged most of this to discredit me, as he is fearful of being caught: I am the second person _____ has identified as poor in _____ years, and whom _____ moved into his home for sex, then evicted with his ranger friends. The previous incident was in _____ I believe. Without seeing any evidence, how can I prepare defense?

The judge repeatedly equated me writing on a wall as domestic violence, but rape, corroborated with the medical reports I provided, as a lesser crime.

I am loud because I am _____, I am emotional because of the trauma I have been through. the sexist, abelist,, and discriminatory actions of the judge need to be considered.

The judge claimed I did "_____". But I did: My point was, on that day I wrote a warning to _____ on the wall. _____ did nothing: did not end the relationship, did not contact anyone about this. _____ then continued to have sex daily for another _____ week,s which he admitted to the judge.

Yes I attempted to contact _____: I wanted my wallet returned, which the judge kept dismissing the issue as irrelevant. But the fact that _____, took my wallet, barred me from getting objective police report from the rangers are very relevant facts; they demonstrate _____ abuse towards me, and prove _____ is not being truthful in court: On _____ when I went into the library, _____ was actually overseeing a group of women chopping up all my belongings. (mostly clothing). _____ then made me exit the library, locked the door, and kept my purse and wallet inside. My purse was eventually returned but no wallet.

_____ mismanaged this case with their constant bias against me because I am loud: a traumatized person can be loud; that is trauma. but the _____ court refuses to acknowledge the facts.

The judge then immediately dismissed my small claims. I had lots of evidence of sexual assault. The judge is dismissing rape, telling the sexual assault victim she is not even worthy of medical costs to be paid. How is this justice? How is it right that I endure sex sometimes every _____ hours until my body is literally broken inside, and _____ did not deny any of these actions in court. I provided sufficient evidence, and _____ even corroborated the dates of the sexual activity. the judge clearly had no intention of considering my case: Anytime I tried to speak the judge berated me and derided me. anytime spoke, the judge gave him up to 5 minutes of silence to "think of an answer".

Again, the judge took writing on a wall a larger crime than daily sexual abuse. How is this just? I now have a criminal record of "domestic violence", where _____ continues to abuse his position as a librarian to traffic poor people for sex.
