ORDER

The Complainant alleged a superior court judge (now retired) was involved in a fake trial, conviction, and hearings in a criminal case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Joseph C. Kreamer did not participate in the consideration of this matter.

 JUDGE MCGUIRE ALSO CONVICTED ME ON ALL CHARGES.

Continue throughout the entire trial, at jury selection on the 3rd set of jurors after a mistrial by the judge on the chambers meeting - my 2 attorneys told me to hold jury selection. I believe the DAs stuck lots of false info to potential jurors. I was convicted twice in 2 trials for the same charges. I know my 1st trial was illegal and he knew I was released by Judge (Retired)

He sent me to death. He knew it was all illegal. I wasn't at my 1st trial, fake witnesses, fake experts, convictions all done without my knowledge and he still did a complete 2nd trial with 2 attorneys who I believe worked for DAs. I'm not the only one who had multiple trials illegal - 8-15 others on death row also had illegal trials. I didn't find out until after I got to Mesa Jail when I read the transcripts given to me by (fake) legal defenders office in PHX. At death row I've been 100% isolated from any people I've been allowed to see or talk with have been fake DOC funded attorneys who work with DAs & AG's & put me on death row illegally for 14 years.

I was him, my 2 attorneys, the DAs locked up. DOC does not want me back at DOC, maybe they want me back so I never wind up somewhere else. my # 15

The court wants to get rid of me. Please me ASAP.
