**ORDER**

June 10, 2025

The Complainant alleged a superior court judge made improper rulings and may be personally biased in a family law case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Denise K. Aguilar, Joseph C. Kreamer, and Scott H. O'Connor did not participate in the consideration of this matter.

Every individual person involved in this case needs to be investigated. I testified about SEVERE sexual abuse as well as other domestic violence. I provided an ENORMOUS amount of evidence proving as such. I have made reports to the beginning in . More calls to the Police Department than I can count and complaints against . I noted to Judge that an email was sent to the Forensic Psychologist involved in this case that her report is riddled with lies. She told me that I had to seek therapy in the United States, that I needed to work on my writing skills, and told me that my abusive mother cried at the end of her interview and that she really cares and is concerned about me. MY parenting time was reduced because I cried and was emotional. As I stated in my email below as well as the motion that this corrupt system made me file, myself and my children WILL NO LONGER be abused by Father, his counsel, the Hon. or this court system.

I will no longer be abused by Father, his counsel or this court system. I am requesting that the court make a decision to either grant Myself sole custody of the children or Father sole custody of the children.
