ORDER

The Complainant alleged a retired superior court judge had a conflict in handling her criminal case in 2021.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Regina L. Nassen and Christopher P. Staring did not participate in the consideration of this matter.

Dear Arizona Commission on Judicial Conduct;

I want to start off this letter by saying thank you for giving me the opportunity to write to you. I am a great grandmother, a seminary Ph.D. student, and an Arizona property owner.

On _____, I was released from a _____ year prison sentence from the Arizona Department of Corrections for a crime that I did not commit. It's case # _____. The charges originated in a small city, right off of the _____ reservation. The incident occurred on _____ when a local drug dealer, named _____ accused me of hitting her with my _____. Here is some background and details about the case:

* _____ had put 2 other people in prison, based on her lies. One of the incidents: after one of _____'s boyfriends, named _____ broke up with her, she planted _____ in his house, then called the police and testified against him. He was killed in prison.

* Even though _____ had an intimate relationship with my father, I did not know _____ beforehand, nor, would I recognize her up-close today, despite her deformed shaped head (_____).

* When _____ moved-in across the street, she changed this quiet neighborhood into a high traffic drug community. I started taking pictures and documenting the numerous vehicles, time of arrival/ departure, and what I could see of the happenings of her visitors. Besides others, the visitors included (that I know of): 2 local _____ court employees; a probation officer named _____; _____'s best friend who worked in the public defender's office (later she was the Jail Liaison for _____), her name is _____; and the person who visited _____ the most was _____'s husband is _____ City Police Officer Sergeant _____ Officer _____ had been at her home also a few times.

* _____ and _____ grew up living next door to each other. They would walk to school together.

* _____ was a _____ Police Officer in _____ when the whole _____ Police Department was fired due to police misconduct. He found out that there was going to be firings beforehand, so he went to the County Sheriff's Department and worked for them until _____ started re-hiring officers, which was when _____ got re-hired and went back to working as a _____ Police Officer. At least three former _____ Police employees were re-hired. Besides being a questionable hiring practice, this is a conflict of interest. There is not a _____ Police Department Internal Affairs, nor ANY, whatsoever, _____ Police oversight!

* During the re-hiring time, _____ County Sheriff's Department was in charge of and covering all of the calls for the _____ Police Department until they could close the investigation and hire new police officers. Since they hired _____ this was a conflict of interest. There is also not a _____ County Sheriff's Internal Affairs Office, nor any _____ County Sheriff's oversight!

* The drug dealer, named _____ called 911 around _____ on _____. The police recording for the call said, "I was just almost hit."

* I had been at the _____ since _____

* _____'s friend, Officer _____, though he and his wife had been at her home many times and he was an old friend of hers, arrived at her home to take the report. He should have had someone else take the call, due to it being a conflict of interest.

* _____'s story changed from just being "ALMOST hit," to being hit. Later, in Court, when I was getting restraining orders against her, she changed her story two other times, going as far as stating that I ran over her with my _____, then immediately dragged her out of her home while punching her, then I tried kidnapping her, but she escaped when I threw her into the passenger side of my _____. This is all on Court documents/recordings. (_____ is _____ years younger than me and at that time was _____ pounds bigger than me, plus I have _____ from a _____, so there is no physical way that this could have happened).

* When I returned home from the church _____, after _____, I was arrested for hitting her with my vehicle. I was NOT read my Miranda Rights.

* There was NEVER a proper police investigation, as would have happened in any other town/city where the police and their wives ARE NOT good friends with drug dealers:

* My vehicle, a _____ customized _____, was never once impounded, nor was the brand new custom front bumper's height EVER measured against where _____ stated that she was hit.

* Pictures of the road, fence, or the sidewalk were never taken. There would have been tire skid/braking marks. Plus the fence would have been hit.

* The interrogation was done by _____. Another conflict of interest!

* I mentioned in the interrogation how I had been taking pictures and documenting the drug traffic across the street from where I lived. I also mentioned in the interrogation how in _____ I had given a _____ Police Officer a report and a light blue jump drive with copies of my video cameras' footage of _____'s new boyfriend inside of my home, and how the _____ Police lost both the Report and the jump drive. All of this was removed from the interrogation video that was given to the court and the public defender.

* I kept telling the interrogator, NUMEROUS TIMES during the interrogation, that all he needs to do is to call the 30+ people who were at the church _____ to verify that I was at the _____ for at least _____ minutes before _____ called 911. Those parts were also removed from the interrogation video that was submitted to the court and the public defender's office.

* The arresting officer called my eye witnesses from the church _____. He told the interrogator THREE TIMES, "She has an airtight alibi." After the third time, the CORRUPT interrogator, _____ Police Officer _____, literally said, "I don't like how she is talking to me, lock her up." If the _____ Police Department is honest and transparent, and not corrupt, ALL of what I just wrote will be on their police body cameras, including what the arresting officer said to me from the _____ City jail to the county jail. This will prove that I should NEVER have been arrested.

* I spent the night in the county jail in my church clothes. The next day I told the judge the whole story. The judge told me that she had heard a similar story and released me on my own recognisance, ordering me to immediately get a restraining order against _____, which I did.

* The court hearing was on _____. My name was never called. The judge said that it was removed from the docket because my file never came from the jail. A elderly Priesthood member of the _____ Brother _____ who was there at the _____, came

with me to testify on my behalf that I was at the church during the time in which _____ states that I had hit her. He also previously came with me to the _____ Court to testify for me to get a restraining order against _____.

* Since my name was removed from the docket, I thought that the whole thing was behind me. I went to _____ for _____ months, leaving in _____, to pick up my son from college after he had been hit by a drunk driver.

* _____, the local drug dealer, continued to call the police on me almost every day while I was in _____.

* UNETHICALLY, without ever calling me, without ever emailing me, WITHOUT EVER SERVING ME, nor even a letter in the mail, the _____ County _____ Court had a grand jury that charged me with three counts of Aggravated Assault. TWO OF THE CHARGES HAPPENED IN ARIZONA WHEN I WAS IN ACTUALLY _____.

* When I got home in _____, with COVID, my home and garage had been broken into with many personal belongings missing, including a whole gun safe with various guns inside of it. There was also graffiti spray painted on the wall in my dining room. When I called to report it, the _____ Police arrived.

* I was immediately arrested. The two _____ Police Officers refused to tell me what I was being arrested for. I later found out that it was for three counts of Aggravated Assault, and I was looking at _____ years in prison.

* TO THIS DAY THE EVIDENCE TO CLEAR ME HAS NEVER BEEN SUBMITTED TO THE COURT EVEN THOUGH I KEPT TELLING THE ATTORNEYS TO GET IT (the Public Defender's Office, where _____'s best friend, _____ worked, nor the court-appointed attorneys refused to get ANY evidence):

* The 30+ church members statements swearing that I was at the church's _____ when _____ states that I hit/ran-over her; and the

* Evidence that I was in _____ in _____ to _____: _____ videos (which are all stored forever with _____), _____ gas stations videos, _____ & _____ videos, and _____ posts showing that I was in _____.

* One of the times that the drug dealer, _____ spoke UNDER OATH at the hearings, she accused me of wearing a black dress and pointy hat, with a wand, drawing a pentagram in the dirt in her front yard, casting a spell. This is on court documents. Everyone, including the judge laughed at her, yet my attorney, nor the Judge, said anything about her truthfulness, nor the fact that she has _____ and a long history with drugs and Family Court.

* One of the times that _____ arrived in _____ Court, she was wearing her pajamas and a long gray wig. I was accompanied by a Victim's Advocate from _____'s _____ in _____.

* The last two times that _____ went to the _____ Court hearings in regards to this matter, she was wearing medical scrubs. UNDER OATH, both times, _____ stated that she was a doctor who performs surgeries in _____ and _____. This is also on court documents. Neither time did my acting attorney, nor the judge, ever challenge her truthfulness or history in court.

* Even though other _____ Court trials were going on, after being in the County Jail for _____ months waiting for my trial, my attorney told me that it would be at least another _____ months before I had a trial. I was extremely sick, bleeding out of every orifice, and lost over _____ pounds (the jail refused to give me my prescription medication, nor my ASV breathing machine, which is still there to this day). My children convinced me to take a plea so that I could get medical attention.

* I was looking at _____ years in prison, yet the judge gave me _____ years of probation.

* The Judge who sentenced me to Probation was Judge _____. Him and I grew up together. His parents and mine

were business partners for many years. His family went to my mother's funeral and I went to his mother's funeral. Besides being unethical, Judge _____ presiding over a case with me as a party should be illegal, possibly under Rule 2.11 of the Model Code of Judicial Conduct. The situation was a serious conflict of interest.

* On probation, I had _____ surgery. One day, out of the blue, my first _____ County probation officer, _____, told me that I had to come into the office within the hour or be thrown in prison. I asked why, she said because she is telling me to. There was no violation. I reminded her that I had informed her beforehand that I had _____ surgery and was not supposed to walk on it for at least _____ weeks. She did not care. I went there, fell several times, broke my _____ and my _____ and tore both of _____ when I tried stopping my falls. To repair the damage, I had _____ surgeries: the screw removed from my _____; another screw inserted into my _____; and _____ repair surgery. The _____ repair surgery is on hold, due to a medical situation.

* A few months later, I informed my male probation officer that there's a conflict of interest when Probation Officer _____ fills in for him, because she's friends with the drug dealer, _____. I used my chain of command and never spoke with Officer _____ about this fact. It was a simple comment, but the male probation officer tried to engage me in an argument. I tried walking away SEVERAL times, this is all on probation office video, I made sure that I stayed within the camera limits. IN RETALIATION, Officer _____, who is around _____ pounds and much taller than me, formally accused me of several counts of the probation violation of threatening her (I'm at least _____ years older than _____, have numerous medical problems, 5', and at that time, I was around _____ pounds. I was never EVER rude to her. Knowing that she was friends with _____, I made it a point to be always overly-kind and overly-respectful to her and always tried to stay within video camera range when dealing with her).

* I was also charged with the probation violation of having an alcoholic beverage. I was NEVER given a breathalyzer test the whole time that I was on probation. I do not drink alcohol! Plus I can not drink alcohol due to several medical reasons and a medical device. The probation office was informed of this fact during my initial visit.

* I was denied an Application for a Veteran's Hearing because the day that _____ (who is in charge of the Veteran's Hearings) was supposed to give me the Application, she was put on Administrative Leave because _____'s best friend, _____, accused her of something that proved to be false.

* I was sent to prison. I finished my sentence on _____.

* While in prison, even though I have a documented history of _____ in _____, a _____ in _____, and a _____ in _____, I was placed on a working yard where I had another _____ on _____.

There are several other items related to this case that need mentioning about the _____ County government and the City of _____ Police Department, such as:

* Illegal racist hiring practices;

* Failure to notify the ATF of stolen weapons. A few of my pistols and rifles that were stolen, I submitted the serial numbers with the report. The last time that I checked, they were never submitted to the ATF for the national stolen weapon databank;

* Racial discrimination;

* Police brutality on _____ women;

* Police Harassment. When I got arrested by the parole officers, they called _____ Police Officer _____. _____ vindictively came to the County jail and stood and watched them process me (he was doing nothing else, nor was he there for anything else);

- * Falsifying evidence;
- * Submitting false statements/reports to the court;
- * Lying under oath in court;
- * Willful deceit;
- * Malicious and vindictive prosecution;
- * Discrimination;
- * Police retaliation;
- * Failure to serve restraining orders (I have two restraining orders that have never been served to one of
 ’s married boyfriends [the one that was on the videos inside and outside of my home]. I listed his licence
 plate number and where he works);
- * Refusal to enforce court orders, i.e. restraining orders against the drug dealer ;
- * Refusal to write police reports for break-ins. During the time that lived across the street from me, my home
 was broken into &/or robbed at least 8 times. I caught her &/or her married boyfriend on video several
 times. Two of the times, I showed the videos to the Police, who had the audacity to tell me that I did not
 have nor her boyfriend’s permission to film them, so the video would not hold up in court. They
 refused to take the Break-In Reports;
- * One of the times that I reported a robbery and submitted a list of stolen items, Officer arrived to
 take the report. had the audacity to tell me that he witnessed the robbery and it was my son who had
 removed items from my home. never asked for I.D. from the person who claimed to be my son. My son
 was in with a after a drunk driver hit the . So stood by and watched as my home was
 being robbed.
- * Three times, when I called to make a police report, I specifically asked that the Police Department NOT
 send Officer . Two of the times, they did anyway.
- * Abuse of power.

I’m writing to you, in hopes that your Office can help clear my name and give me my reputation and dignity back. I did not do the things that I went to prison for. Throughout my life, I have been a responsible and educated, voting community member who was politically, civically, and religiously engaged. It all changed because of a local drug dealer and the corrupt authorities who are friends with her. Any help that you can give will be greatly appreciated. Thank you.
