The Complainant alleged a superior court judge made improper rulings, was not competent, and was biased against Complainant's lawyers.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Dear Honorable Chair _____:

I respectfully submit the attached complaint concerning the conduct of Judge _____ in case _____. After careful consideration and with great reluctance, I have concluded that this matter warrants the Commission's attention due to the serious nature of the judicial misconduct and its profound impact on the administration of justice.

The detailed complaint provides extensive documentation of Judge _____ actions that appear to violate multiple provisions of the Arizona Code of Judicial Conduct. Of particular concern is the judge's:

1. Failure to address clear and compelling forensic evidence of document forgery
2. Refusal to order production of dispositive evidence
3. Disregard for admitted destruction of electronic communications and business records
4. Acknowledgment of her lack of competence to handle complex commercial matters while refusing to transfer the case
5. Pattern of one-word rulings on matters with significant legal and financial implications

The implications of Judge _____ conduct extend far beyond my individual case. When a judge ignores clear evidence of document forgery, permits the destruction of electronic communications subject to litigation holds, and allows proven falsifications to stand unchallenged, it sends a dangerous message about the integrity of our judicial system. Such conduct effectively rewards those who engage in misconduct while punishing honest litigants who follow the rules. If left unaddressed, this behavior risks establishing a precedent where the rule of law becomes subordinate to those willing to fabricate evidence and commit perjury. The Commission's intervention is essential not only to address the specific violations in this case but to affirm that our courts remain places where truth matters and where the rules of evidence and procedure are applied equally to all.

I am a _____-year-old _____ survivor and naturalized U.S. citizen who has spent over _____ years as an entrepreneur. This matter has caused significant personal hardship for my wife (also a survivor) and me, depleting our retirement funds and adversely affecting our health. Judge _____ abject failures to comply with the Rules of Judicial Conduct have alone cost us

hundreds of thousands of dollars in legal fees and lost business opportunities. However, my primary concern in filing this complaint is the integrity of our judicial system.

The attached exhibits include sworn testimony, forensic evidence, court transcripts, and other documentation that substantiate each allegation. I have also included an impartial analysis of the evidence regarding the authenticity of a key document, prepared with the assistance of an AI tool to provide an objective assessment.

I understand the Commission's vital role in maintaining the integrity of Arizona's judiciary, and I do not undertake this complaint lightly. As citizens, we have no choice but to rely on the judicial system to protect us from fraud and deceit—there is no alternative. The Rules of Judicial Conduct are all that stand between honest citizens and those who would manipulate the system through falsified evidence and perjury. When judges fail to enforce these rules, the entire foundation of our legal system is compromised. I respectfully request that the Commission carefully review the evidence presented and take appropriate action to address these serious violations of judicial conduct.
