The Complainant alleged a superior court judge's clerk tampered with paperwork in a child custody case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Regina L. Nassen did not participate in the consideration of this matter.

To whom it may concern. I do apologize for the timing of this complaint. Reason being I was busy fighting my own custody case because of the incompetent performance of my attorney's and Judge who either was not aware or familiar with family law or just in over her head, or maybe just decided under the color of authority to handle this case in her own way.

I'll start from the beginning. I've had custody of my child since the age of months. lost custody in Court in Since then has filed false reports on me. All her complaint were investigated, my child and I were both interviewed and was interviewed as well. The results of these interviews were the same in all cases filed that the child remains in the custody of the Father me (). However that wasn't good enough for She also filed a Domestic Violence and a Restraining Order charge on me saying I went to Arizona to commit these acts. That was found by Court to be untrue and the charges were dropped.

Time passed by and in picked the child up from me on a regular weekend visit and she then filed another Domestic Violence and Restraining Order on me because I called the AZ Police Department to do a wellness check on my child as I found out was living with and married to a guy with a felony warrant for gun charge. At the same time was also dating the handyman whom she gave birth to a child while still living with her husband a very much older man. I don't care how she lives her life, but I do not want my year old daughter caught up in the middle of this mess. files a retraining order with Municipal Court, the same order she filed with Court. That charge too was turned down. court informed. I was only doing a wellness check on my child.

Now time is running out and she has to bring my child back, but she doesn't want to do that because she found out my child has money coming to her that I file with for her education. I put my child in a School when she was with me. As a single parent I just assume I would need all the help I could get.

then goes to court and place the same charges of Domestic Violence and a Retraining Order on me again. We also have a child custody case in Case No. On however filed her charges on in which the Judge informed me to answer those charges before he will bring the child back to me. Here's where the case get mishandled. once worked at the Court maybe as a I'm not sure. I then contacted Court to gain information on the filing of me case. They informed me that it was against the law at what was doing and sent an email to the Court on the ruling of this case and judge shopping or (Form Shopping) was against the law. I was emailing

several time and even sent notarized paperwork to her about my case because she told me since my case was already ruled on in the AZ Court the judge would only need to read my response and she would make a ruling base on the evidence she read in front of her.

Meanwhile back here in my attorney was waiting on Judge decision, it's been weeks now and we haven't heard a word. My Court date was Now out of time I called AZ Court and now I can't reach . But another court clerk by the name of () answered my call and I explained my situation to her. She then told me she has been trying to reach me for weeks via email. I explained to her I got nothing and what email had she used. told me she got my email address from . Who intentionally gave the wrong email address so that I wouldn't be notified to show up in court via phone court conference. also withheld my court response to restraining order and also the email that AZ court clerk name () sent to AZ Court to Judge

Now my main concern is and it should be yours as well. How many other case has tampered with helping a acquaintance? My little girl is now stuck in the hands of a woman that's mentally unstable and has a drug and alcohol problem. is also under the influence of psych meds, and has been in several major car accidents.

I've done all I can to save faith for my child and to keep her safe and out of harms way. But what can you do when the system that suppose to keep the honor that protects you, fails you? These are not my words against . These are the words of the system that let's you know when something is wrong. I've even called AZ Department () to inform them to do a wellness check. from informed me she would go to school to check on my child. I asked of how is my lil girl doing, her reply to me was, “ then made an attempt to visit home. However refuses to open the door to let that happen. Instead the agent that's suppose to do the wellness check shared with all the information I had given her to do the wellness check and then told her to what to do to her house so that they can come in.

The system is not working at all. I need help. My child needs help before it's too late. There's also another year old little girl stuck in that broken home that's in need of help also.

Her father is fighting the exact same fight that I'm fighting now and have been for a number of years now. I've done all I could or had to do. I've spoken to on different occasions. I've spoken to court order Psychiatrist. Several sheriff officers. has displayed this exact same behavior before in where she has abducted the child and hid out in Arizona, only this time she's getting away with her bad deeds, lies and the help of Court system.

[redacted] — Authorities are asking for the public's help with a parental abduction involving a [redacted]-month old girl, officials said.
