ORDER

The Complainants alleged a justice of the peace improperly denied a protective order, was biased against Complainants, and had ex parte communications.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

[] and [] We were requesting a court order of protection against [] and her two accomplices; [] and [] for harassing our family. Intimidation, verbal abuse and trespassing on our property, as well as provoking our dogs. She threatened to rope off our driveway and forbid us from using our driveway. A driveway we have used since living here for [] years. My younger son and I are disabled, not to mention that we have needs and cannot be trapped without having access out of our home. This is an illegal act. This is after she stated that she will not touch the driveway. This took place on [], after the police were called. Police were called many times due to this ongoing threat. The police informed us that it is Civil, so there is nothing that they can do but for us to talk to Judge [] to obtain a Court Order of Injunction Against Harassment. Anytime we're on the driveway in question we would get harassed verbally by []

On [] was the first hearing in [] Arizona. We pleaded our case to Judge [], we had videos and photos proving harassment was committed by [], and [] We stated that [] on [], at approx. [] in the morning was trespassing on our property with [] and [] verbally assaulting me and my son [] Called me a [] and [] clearly on our property. The police prior told us to get them on video so my son came out of the house recording the whole situation. I went into the house to call the police, proceeded to trespass flaunting a firearm that he had strapped on his person while he was aggressively screaming and yelling getting in our faces calling us names, waving arms, screaming and getting in the face of my son calling him [], making baby noises and gestures proceeding to scream vulgar words in which my [] son had witnessed this nightmare. He still can't sleep at night, has nightmares and talks about it frequently. He is now afraid to be left alone because on [], we were arrested and he was in the house and witnessed us being arrested. The officer would not allow us to go see him because we had been arrested unlawfully. He would not allow me to go tend to my special needs son. Due to this he is afraid to be left alone. [], holding a rope, started saying she is going to rope us off our property. We to this day have lived in fear of what she is going to try to do next or have her accomplices do something to harm us.

Judge [] denied our request. Judge [] gave [] permission to commit these illegal acts. This is unethical/illegal for them to continue their illegal acts and roping us off of our driveway.

- Case and point.
1. He seemed very biased against us in favor of []
 2. He didn't seem to care at all in detail with what I or [] had to say.
 3. [] perjured herself by saying that I pulled up property stakes when she had a survey done that I did not do and has no proof of that. Yet Judge [] believed her.
 4. We outlined all the facts and verbally begged him to look out for the safety of my family. They always carry a gun and are clearly unhinged people that will do anything to get what they want ignoring the law. We are afraid. We have said we are afraid to Judge [] countless times. They are aggressive and will stop at nothing from roping us off the driveway. After pleading several times in two different hearings, he denied both. [] allowed them to continue to harass my family. His final ruling was for us to obtain a lawyer and take it to [] Court. That is exactly what we did the next day.

Again, this is an unethical act by Judge _____. Due to Judge _____ allowing _____ and _____ illegal act of roping off the driveway, they continued with one more attempt the following week. If Judge _____ granted us our Injunction Against Harassment on _____, the horrific incident on _____ would've never happened. Instead, the three of them again proceeded to trespass and rope us off of our driveway. _____ had called dispatch at approx. _____. She said she is going to rope off her driveway and needed a police officer to "_____". _____ stated how the police have been out here before. She started laughing. What followed was a chain reaction of illegal acts of:

1. Police Misconduct
2. False Arrest x3 (Trespassing, Disorderly Conduct, False Arrest)
3. Police brutality
4. Police Assault
5. Destruction Of Private Property
6. Trespass
7. Roping off access of driveway
8. Selective Enforcement.

Our Civil Rights were violated. Due to the Police Officers misconduct, made my disabled conditions extremely worse requiring surgery. Because of Judge _____ not granting our injunction against harassment on _____ allowed _____ and _____ again to do all of this traumatic unnecessary horrific torture that we've had to endure and are still dealing with to this day. This could have and should have been all avoided when we were crying for help and Judge denied us. Not only my younger son and I disabled, but this put us into an unimaginable hardship. My family has suffered emotionally, physically, and financially due to all of these illegal acts that were unjustly brought upon us. _____ was handed a victims rights packet. We were the true victims in this case.

_____ went to the judge again for another Injunction against Harassment because of _____ when _____ started putting up cameras on her illegal barn that she has not obtained building permits for and is not up to code which she has gotten away with. _____ and _____ continued to threaten with aggressive/obscene gestures and threatening behavior with plotting and coming very close to again, trespass and destruction of property. _____ put cameras up facing our home, bedroom, bathroom, and front yard. She was still perjuring herself with lies about me saying I've done things that I never did.(defamation)

In the hearing we mentioned we have proof with photos and videos of this continued harassment and Judge _____ was fully aware what had happened to us to this point unjustly on _____ said "_____". He denies our request for Injunction Against Harassment once again. He asks _____ where the lawsuit is. She says "_____". She has actually been in default the entire time during these occurrences, both judge _____ and _____ are well aware we have an attorney in this matter due to the dispute over the driveway. She has never contacted my attorney in this lawsuit. She has chosen to ignore our attorney and laws that are in place. Instead she has chosen to torture and harass us and commit illegal things to my family and Judge _____ has allowed her to get away with it all. Judge _____ needs to face the consequences of his bad decisions and the encouragement of illegal acts that were inflicted upon us. My family and I are traumatized from this and will be for the rest of our lives.
