**ORDER**

August 22, 2025

The Complainant alleged a superior court judge improperly left people on a jury who had financial connections to the defendant in a civil case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Copies of this order were distributed to all appropriate persons on August 22, 2025.

at . I saw the lawyers go up and talk to the Judge about removing them, but the judge left them in place on the jury (that is where the corruption starts). ((The Judge should have never left jurors that were friends, coworkers, and money employers as Jurors!)) Well during our deliberation I came to believe that it was much more than just money contracts at work between and these employee Jurors.

It was very suspicious how it was pushed to get [redacted] released of any responsibility for the accident. Which in the end is what was accomplished. [redacted] was in the police report as the one causing the 3 car accident, rear ending the [redacted] and then pushing him into the car in front of him and then into the guardrail. Yet he got off being said he was not at any fault of the accident by the jury, this was against what all the evidence showed. I disagreed during the deliberation but I was not listened to. I understand that anytime you are the one causing an accident especially rear ending someone that you are at fault and responsible. But yet they said he wasn't at fault, just because they work with him and are in direct connection of money contracts between [redacted] in [redacted] and his personal Contractor Business that is employed by [redacted] in [redacted]. Even if I'm mistaken they should not have stayed on the Jury knowing that there was money dealing with [redacted] at work, this is corrupt, and a conflict of interest.
