ORDER

The Complainant alleged a justice of the peace improperly granted a protective order.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Michael J. Brown did not participate in the consideration of this matter.

They told me we gonna go to Arizona and we drove _____ hours when _____ was not sick handled all the hours drive. But we stopped at _____. They surprised me they got a hotel at the hotel. I asked why ? They said they wanted to show me the _____ area. I got an other one by _____. Then after they took me to restaurants, and the casino itself. Then finally we drove to the house. There I was showed my room and what I will need to do, where is this and where is that. But here came my next surprise. Since we drive with a rent a car and _____ always rented a car when he came from _____. Since he still was working, he packed and head it back ,but for my surprises _____ stayed. I thought that is strange and that not what I was told ,but it was her house and I did not know anyone NO ONE in the middle of the desert. I got some strange stuff on the _____ too,but all those if they going to do an investigation will come out. Before _____ headed back to _____ they took me to the DMV and renewed my license on her address Then _____ came and went back to _____ take us to restaurants even I bought food I told them we have a lot in the house. Also for there Birthday back in _____ and _____ I got them cakes with balloons what I invited the cleaning lady too also when they requested me for some specialty I gave some to _____ who latter after the order bring back only half of my stuff,and opened my mail. So now I have ID theft top of everything I have to deal with. I am not saying it is them until _____ will hopefully find who is it but you just do not open someone mail especially you put a complete fabrication lies and a fraud order on someone. But they give the _____ expensive gifts and unfortunately I am not buy able.,But still I was there by myself with out to know anyone. In _____ is a small town everybody knows each other like lawyers etc. I did not know anyone I was brand new to that area.,Open someone mail is a fed offen Then _____ business partner/husband came down again we went to _____. He pushed me in the lady's room with _____.said help her. She had no medical condition . She even told me all her exam is perfect., The only problem is her legs. It was full of water due to her approximately _____ or _____ pound. But of course they going to blame it on me on at the court. When she is like that last _____ or more years,on my cooking. She blames me at the hearing,but I will have pictures on her like _____ years earlier the same weight. Fast forward they lied the order She stated I threatened the locksmith at the hearing I told the judge I never threatened no one. I went and find the locksmith told them what they say in the order he said it is not true. But he has _____ children and he does not wanted to go to the hearing,but gave me his card and told me tell the judge call him up. What I did but the judge did NOT called. And refused card jet ticket. I asked for a hearing and was deter-mend to fight this nonsense. With my clean rec. Oh they had a lawyer who said I trans passed. Since I did not know anyone and had no money I represented or tried to represent myself on that kangaroo court. Then I called up the care givers boss _____. But since she went in with the wheelchair front of the Judge with the poor me syndrome, the Judge or Judicial Officer , put this on me and she signed it under penalty of perjury. She is not sick I seen them this spring 2 times passing by on . Business partner said in the hearing she is severely ill. If someone is like that and would need 24/7 what they, stated ,wont drive hours from . Also at the hearing they did not show up. Send this Lawyer who represents a lots of people in that court. And said I am a trans passer. Then the second court date again they did not show up. But send a letter she can not come .They here now. But not by a doctor but by a social worker. But all what they were saying what is on the CD the last one 3 hours all was a lie and I can prove the opposite, if your office gonna start an investigation. What really happened here. It was bad how I was humiliated front of nice neighbors, when the constable came .,After all the harassment I called in the morning from the house phone the sheriff what was listening to so out of revenge they put this order on me. And called the constable in the afternoon Since even the sheriff told me you need to sue those scammers.,She is not ill. And definitely do not need a 24 /7 care and not severally ill what yelled at me at the third hearing. But I do not want to go to the details . there if they going to do an investigation what I was promised by the police and the DA. If not please refer-me to the higher up , Because these scammers told me they plan to scam an other lady to the house . This has to be stooped. And her to abuse her “handicap” status. So make it sort on the third hearing the Judge let them use zoom they read all the answers. I tell the Judge wait a minutes this is not right. And all those irregularity of the court proceedings So they red all the lies. Then the Judge at the end saying he does not believe them , but yet DID NOT MOVED THE ORDER FROM ME,.A COMPLETE LIE AND FRAUD UNDER OATH Then I ended at the ER in the hospital due to emotional distress and listen to all the lies,fabrication. Then I put in a motion for a new hearing, calling the court almost on the daily base for answer. Of course the Judge not answered me in a technical maneuver just after my deadline for appeal. Please your office could call from court all the three hearings CD and my motion for the hearing to fight it, also the actual order on me. Correcting or setting aside permanently clearing out the order ,misrepresentation fraud,and all the misconduct of the opposing party. Also the court process .
