**ORDER**

October 3, 2025

The Complainant alleged a superior court judge failed to follow the law in a criminal matter.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Denise K. Aguilar did not participate in the consideration of this matter.

Dear Commission Members,

I am submitting this complaint regarding the conduct of the presiding judge \_\_\_\_\_ in my criminal matter in \_\_\_\_\_ County \_\_\_\_\_ Court. I believe the judge's actions violated the Arizona Code of Judicial Conduct by failing to uphold impartiality, transparency, and due process.

Specifically, I raise the following concerns:

1. **Improper Venue Change Without Notice or Waiver** A hearing was held without my knowledge or participation, during which my trial was vacated and reassigned to a

different judge and courthouse. I was not notified, nor did I waive my right to venue. This change caused financial hardship and logistical disruption, and appears to have been made solely for the court's convenience.

2. **Endorsement of Prosecutorial Retaliation** After I declined a plea offer during a remote hearing, the prosecutor made disparaging remarks about my location (sitting outside in ) and requested that I be forced to appear in person. The judge agreed—despite pandemic protocols and no legal necessity—creating the appearance of retaliation for exercising my right to trial.
3. **Failure to Ensure My Right to Be Heard** The judge allowed critical decisions to be made in my absence, failed to inquire into my repeated concerns about ineffective counsel, and did not ensure that I was meaningfully included in proceedings that materially affected my case.

These actions violate **Canon 1 (Integrity), Canon 2 (Impartiality and Fairness), and Canon 2.6 (Ensuring the Right to Be Heard)** of the Arizona Code of Judicial Conduct. I respectfully request that the Commission investigate whether this judge's conduct warrants corrective or disciplinary action.
