The Complainant alleged a superior court commissioner failed to follow the law in a mental health matter.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Colleen E. Concannon, Joseph C. Kreamer, and Regina L. Nassen did not participate in the consideration of this matter.

Within the attachments are two pages. highlighted: On one page is the statement under #6 highlighted, and it says, ' [] I have never used my car to hit and kill anyone, this is Libel and yes I have filed a complaint against [] and your Honorable Commissioner signed off on this statement as being true, when I have NEVER killed anyone.

The statement highlighted in pink is the misdiagnosis given by [] and your Honorable Commissioner signed off on the misdiagnosis. In [] I was given a mental health diagnosis of [] with [] from the first gulf war and I am permanent and total.

[] made the statement that I refused care, which was misleading, because my concern was that the agency had refused to acknowledge my medication list, which had changed, refused to acknowledge that I already had a [] health diagnosis.

The Honorable Commissioner signed off on the statement of me killing people with cars as being true, and the truth is, I have not hurt anyone and I have definitely not killed anyone.

Can you explain in detail your response [] and Commission. This Libel, which a Commissioner has agreed to, willingly or unwillingly.

If the Commissioner was deceived by [] that is no fault of mine, but is Libel and deprivation of my right to fair and due process.
