**ORDER**

October 14, 2025

The Complainant alleged a municipal court judge did not follow the law.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Colleen E. Concannon, Joseph C. Kreamer, and Regina L. Nassen did not participate in the consideration of this matter.

This is just brief information but records and details are available if needed. I had every right to live my life. I did nothing other than lose my job which I was brilliant at! I do not have psychological problems (minus now since trying to accept I was murdered by my father, mother \_\_\_\_\_ and the courts & hospitals). The \_\_\_\_\_ police are also to blame because I spoke to them regarding my \_\_\_\_\_ wellness, there was no reason for psychiatric evaluation, care or anything. I was told that I'd be evaluated and released within 72hrs (which should have happened) but sadly did not being given a medication meant for someone else or given to me in validity! I'll never know.

What I do know for a fact is that the call was placed by \_\_\_\_\_

That in fact at that time I had nothing wrong.

I complied fully and to this day question why?

I did not purposefully break anything in a violent matter.

I needed the help and protection from \_\_\_\_\_ which was known for years!

My personal things/property were NOT anyone close to take and do whatever with!

My car insurance money was stolen from me unwillingly sum of \_\_\_\_\_ while at one of those forced hospitalizations where I had no choice!

The money, belongings, those break my heart but not nearly as much as I am devastated about the police, hospitals, courts, and friends who have all heard me and done nothing! I want what's right, I deserve justice, no one should ever, and I mean ever experience what I've been through!

This nightmare is ending soon! Any help in any of these areas is welcomed! Whatever you need from me, I'll be here for!

But if nothing happens, I'm unfortunately through letting anyone abuse and break me! I have less than a month of life left, this is what they wanted anyway.

My name is [redacted] and below I broke down the last [redacted] years of my hell since being violated in AS brief of a way to everything in but there's a ton more detail if needed it's available

[redacted] became hospitalized, involuntarily and never told a reason or any information

[redacted] was released from hospital after [redacted] weeks, then taken to a location in [redacted] under care of [redacted] nurses, where I was forced to remain for [redacted] days! Still no word why?

[redacted] began walking abnormally I walked like I had taken a Crip in my pants. Unsteady, unbalanced, like I was drinking or something!

[redacted] began thinking some medication error or something had occurred while hospitalized because no one was explaining a thing, when I demanded, I spoke to everyone and accused everyone and everything trying to figure out what the heck was happening

[redacted] ordered my medical records, and felt as if I were dying rapidly

[redacted] received my medical records to only find I was suspicious for good reason, but that was no help. I found numerous red flags and only more questions without any answers.

[redacted] was still walking with issues now blaming the disease that became of my illness

[redacted] was still having a hard time walking and using the bathroom

[redacted] was laying down so much due to pain it's a blur! I was desperate for answers, help, treatment! Anything!

[redacted] spoke to a new doctor, coming to the conclusion that they were not taking my medical issue serious at all. I began to think,

[redacted] after many conversations about all this I began to suspect harm from someone based on conversation and my scarring

[redacted] wrote grievance @ [redacted] humiliating I was sexually assaulted or raped

[redacted] (leaving medication has stopped until I see a doctor with new bloodwork... Then...

I'm deathly terrified of this hospital as if I was hit and now wilds and PML. My health rapidly declined much of [redacted] all the while blaming some medication error or adverse reaction, a hepatotoxicity is what's in my records (which is documented in my medical records but never told to me) then continued to worsen as my health improved slightly. After [redacted] stopped blaming the hospital but still my scarring didn't make sense. I was harmed, physically I could feel the scarring around my rear end so much it hurt to sit or even just laying down which I did much of. I take responsibility for my health, my aids PML, be it as it may despite the adverse reaction, to a now banned medication called [redacted] if that wasn't the case how did the scarring occur around my rear end [redacted] the medication that destroyed my life! (Generic [redacted] banned by the [redacted])

[redacted] I was placed under arrest for holding a obj fork in defense to gun held to my head and only I was arrested, not my brother who woke me up screaming to get him booze with a gun, but me because of this arrest

[redacted] took a plea to get out of jail unwillingly but needed to be released for safety and was held until [redacted] due to unknown reasons

[redacted] I was bailed out of jail for the hold they had for a failure to appear that I never received documents on being inside a hospital forced never knew I had court! Once I found out I called my father to finally do something about it

For [redacted] weeks [redacted] was forced hospitalized for reasons caused by my medical records changed

[redacted] arrested for breaking a coffee pot when I couldn't turn around accidentally breaking it! Then taken immediately to yet another hospital where I was forced the medications that were killing me

I told the judge both in [redacted] and in [redacted] and likely they dismissed what I was saying because of the severity and unlikelihood of it

When returning to [redacted] for my sentencing which I just wanted to end this I was denied the time I was held in jail and again now forced into a situation I'm uncomfortable with I spent [redacted] weeks forced in hospitalizations for medical issues not diagnosed having jail for [redacted] months near just for the [redacted] hold and nothing is (considered good enough)

But [redacted] was not one time helped stop knowingly preventing these hospitalizations, and watched me suffering and then took it upon himself to either sell, throw away or give away all my things, cards, photos, jewelry, clothing

I am utterly devastated and sad  
I never ever harmed a soul  
I always helped everyone  
I gave my everything to family  
I lead selflessly groups in town for years  
I never once heard a voice or saw things that weren't there!

That night in question I told [redacted] but I had been up late late that even a moment the AC unit almost sounded like my neighbors having conversations on the other side of the wall  
That is a breakdown and I have names, dates and everything saved.

There you go, keep in mind there is a ton more detail!! A ton!
