**ORDER**

October 30, 2025

The Complainant alleged a superior court commissioner improperly issued a warrant for violating probation when the probation had been terminated in a criminal case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Denise K. Aguilar and Colleen E. Concannon did not participate in the consideration of this matter.

Subject: Complaint of Judicial Misconduct – Judge \_\_\_\_\_ ( \_\_\_\_\_ County Court)

To Whom It May Concern:

I am submitting this formal complaint against Judge \_\_\_\_\_ of the \_\_\_\_\_ County Court concerning case number \_\_\_\_\_ . I know Judge \_\_\_\_\_ engaged in serious judicial misconduct by issuing a Probation Violation Arrest Warrant on \_\_\_\_\_ in direct contradiction to an earlier, valid court order officially terminating my probation.

The facts are as follows:

- On \_\_\_\_\_ Presiding Judge \_\_\_\_\_ entered a Minute Entry affirming the full acquittance and discharge of my probation and ordering case closed, contingent only on confirmation of receipt of GSA Bonds by the U.S. Treasury (see enclosed Minute Entry and attestation documents).
- This order was based on a Pro Per Motion filed and attested to as valid by the Clerk of Court and Presiding Judge, certifying that probation had been terminated as of \_\_\_\_\_
- On \_\_\_\_\_ Judge \_\_\_\_\_ issued a Probation Violation Arrest Warrant based on a petition that should have been legally irrelevant given the existing termination order. This directly contradicted the judicial record and violated the legal finality of Judge \_\_\_\_\_ order.

As a result of this improper action:

- I was subjected to unnecessary law enforcement action.
- I endured stress, harassment, and reputational damage.
- My civil liberties were put at risk despite having complied fully with the terms of probation and having received formal discharge.

I believe this constitutes willful judicial misconduct, including:

- Disregard for valid judicial orders

- Abuse of authority
- Causing unlawful harm to a citizen through judicial negligence or malfeasance

I respectfully request that the Commission investigate this matter and take appropriate disciplinary action.
