**ORDER**

February 11, 2026

The Complainant alleged a superior court judge made improper legal rulings regarding the evidence in a family law case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Colleen E. Concannon and Regina L. Nassen did not participate in the consideration of this matter.

The Judge \_\_\_\_\_ failed to acknowledge the felony police report against \_\_\_\_\_ and \_\_\_\_\_ for custodial interference and the aggravated sexual assault from \_\_\_\_\_, both felonies resulted in arrests of the defendants. The Judge would not allow me to enter any evidence into the case and continued to harass me about my mental health, after multiple police reports confirmed that the harassment in these courts is illegal and not founded on any mental health issues observed or confirmed by professionals and are repetitive in nature, evoking protection order violations against the defendant.

The Judge prior to Judge \_\_\_\_\_, Judge \_\_\_\_\_, was removed for the same practice of harassment and child theft practices misusing their judicial power. It is clear they have the full intention to threaten me to stop doing my cybersecurity work, as they often mock me in the court hearings about my cybersecurity.

The \_\_\_\_\_ and \_\_\_\_\_ have confirmed that I have never hurt my child and have the full responsibility to be able to care for her, and removing her and fully blocking her from my care is illegal to the highest Arizona degrees and confirming of trafficking charges currently being investigated, as confirmed with reviews. It is now apparent, after the repetitive nature of the judicial misconduct, that the judges are being paid by the traffickers to attack me and my daughter. The attacks have been lethal several times and I am requesting the support of the judges committee immediately to help return my daughter. I have submitted an appeal to ensure that the case leads to the removal of \_\_\_\_\_ from paternity paperwork, and the return of \_\_\_\_\_ to my motherly care. They stole her as an infant and there is currently a desperate need for speed in judicial oversight support against Judge \_\_\_\_\_.

The Judge originally requested the police reports during the hearing, and then after submitting them, refused to acknowledge them. Multiple evidence reports of mental health confirmation as confirmed by many doctors have been proof of no diagnosis of any mental health illnesses and \_\_\_\_\_ and \_\_\_\_\_ confirmed this as well.

Investigations have been conducted against the judicial malpractice for corruption in civil courts and are being pursued to retrieve \_\_\_\_\_ from the attacks.
