ORDER

The Complainant alleged a superior court judge failed to enforce court orders against the opposing party in a family law case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

From day one you will see in all my correspondence with the court I am exposing who is really behind that mask (the respondent) and what a soft smooth professional talker, a professional liar , professional scammer, a 2 face , a vicious violent criminal and , player , gamer & a great con artist.

One thing about me ,God has gifted me not to be a FOOL , to be very very intelligent and see thru things to what it is and NOT what's being presented to me .

From day one the respondent has been and still is till this day in contempt / disobedience of the judge's orders , keep in mind these are the judges orders not mine nor nobody else's & set in place for the respondent to comply , follow and obey period.

ALL my filing with the court from day one till today has been to notify the judge of the ongoing and asking the judge per her job description to step in and enforce her own orders on the respondent and hold the respondent to the consequences for her actions per LAW .

Now , from day one the judge has turned the court hearing's into lectures lecturing me about how to talk to the respondent which is absolutely it's none of the judges business nor per her job description per law codes , lecturing me that number one priority in her court is the kids interest and some of the phrases I use to call the respondent " " are not proper or appropriate where it's very evident this judge suffers from a severe derangement syndrome because of her to keep dwelling on the subject over and over where that has nothing to do with the contempt of the respondent.

The judge is very very aware and knows very very well who's at fault , who is the wrong , who is the criminal and who is the one who is disobeying her orders BUT my kids and I are ALWAYS punished severely , ask her why she took away from my daily calls to my kids to 2 calls per week ????? Why from the very first contempt I reported to her why she did not hold the respondent responsible???? We had an in person hearing and before that I filled out the financial statement many many times and she knows very very well I don't have a job , no income and disabled YET she forced me to pay a very high amount in Child Support where if not paying I will be in jail . Why every time we have a hearing she changes the subject and spins the contempt and being held accountable to the responding to a totally different hearing / subject and always saying things about section X of the law well it has nothing to do with the hearing trying to throw me off so I get confused and stay quiet ????? My kids and I we are just ordinary citizens that have no affiliation with democrats Republicans or independents or any clubs or chapters or any political affiliations or President . It ALL points to that this judge has severe hate towards my kids and I.

Every time I report to the judge the responded is in contempt of her OWN orders backed with hard evidence, such as police reports , text messages , emails , the JUDGE does NOTHING about it and lets the respondent walk away FREE and not only that my kids and I get severely punished.

This judge could care less about my kids interest and mine as a dad . This judge could care less about my kids feelings and mine. I keep complaining over and over for + long years that what she is doing to my kids and I is very very painful , hurtful, very, very damaging, my kids childhood got robbed, I got robbed from my fatherhood where these days WILL never ever come back , yet she takes the respondent side 110% and backs respondent all the way.

Respondent is in 6 separate contempts and this judge will NOT hold respondent accountable and apply all necessary punishments , why ????? The excuse of statute of limitations is NOT an excuse if this judge wants to use that coz judges, have the authority and power to bring it back . Why is the respondent have six separate contempts ???
