**ORDER**

February 20, 2026

The Complainant alleged a justice of the peace disregarded the law in an eviction matter.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Colleen E. Concannon did not participate in the consideration of this matter.

His clerks threatened us, attempted to assault us, and refused to accept our legal documents. His court lied about everything which we made him aware of, and he completely ignored it and allowed it to continue. He ALWAYS sides with \_\_\_\_\_ in EVERY case she has before him, and she specifically requests him as the judge every time she scams people in his court. He is allowing illegal activity to go on for his own benefit and refused to allow people due process, which is a violation of our amendment rights, specifically our 5th and 14th amendment rights. WE are planning on suing the Judicial committee and state as you guys have allowed this in other courts in AZ and have done absolutely nothing about it.
