**ORDER**

February 20, 2026

The Complainant alleged a superior court judge did not follow the law in a criminal case by failing to dismiss her case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Colleen E. Concannon did not participate in the consideration of this matter.

**FEDERAL RULE OF CIVIL PROCEDURE 11**

(FRCP 11) is a critical rule in U.S. federal courts designed to deter frivolous filings and curb the abuse of the judicial process. It requires attorneys or unrepresented parties to certify that any papers they present to the court have a reasonable basis in fact and law and are not filed for an improper purpose, such as HARASSMENT OR DELAY.

**CORE REQUIREMENTS (RULE 11(B))**

Under Rule 11(b), by presenting a document to the court, a party certifies that, after a reasonable inquiry, it meets several standards: The document must not be presented for an improper purpose.

Legal arguments must be warranted by existing law or a nonfrivolous argument for changing the law.

Factual contentions must have evidentiary support or likely will after further investigation.

Denials of factual contentions must be warranted or reasonably based on a lack of information.

**SANCTIONS AND PROCEDURES (RULE 11(C))**

If a violation occurs, the court can impose sanctions on the responsible party or attorney, aimed at DETERRING REPETITION. Sanctions can include nonmonetary actions, penalties paid to the court, or reasonable attorney's fees for the opposing party.

Rule 11 includes a "safe harbor" provision where a sanctions motion must be served on the opponent 21 days before filing with the court, allowing an opportunity to correct or withdraw the challenged document.

To hold the offending party accountable for:

- years of criminalizing a civil deeded Subdivision Right of Way
  - years of refusing to enforce Subdivision Ordinance Violations
  - years of criminalizing Subdivision Ordinance Violations; against the complainant victim
- filing baseless claims against the Subdivision complainant;
