ORDER

The Complainant alleged a superior court commissioner failed to follow the law and was biased in an order of protection case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Regina L. Nassen did not participate in the consideration of this matter.

The fact that I have documentation through APPCLOSE as well as multiple other forms of documentation and it is ignored by the state of AZ just goes to show that there is no justice for being a good Dad and the state of AZ is biased on fathers as well as promotes doing unethical and illegal things.
