The Complainant alleged a justice of the peace committed a crime.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Roger D. Barton did not participate in the consideration of this matter.

During my tenure as the _____ Executive Director, Judge _____ held multiple areas of function. In legal private practice in the City of _____ and judicially with the County of _____ township. In violation of Arizona law, _____ stole and fraudulently utilized _____ non-profit funds for his "personal" home, ordering building supplies and other materials on the non-profit accounts as evidenced. Simultaneously during this time, as a sitting judge _____ utilized his position on the _____ Board of Directors to intimidate and threaten staff to remain quiet while he performed his egregious criminal acts of embezzlement. His intimidation and threats toward staff have constituted a clear obstruction of justice, violated fundamental legal principles and impeded the fair administration of the law.

By violating the Arizona Rules of Professional Conduct, _____ engaged in deliberate misuse of _____ funds for personal gain, coupled with intimidation and threats toward staff, not only constitutes embezzlement and obstruction of justice but also erodes public trust in both the judiciary and charitable organizations. Such conduct undermines the integrity of the legal profession and nonprofit sector, prompting immediate investigations by appropriate regulatory and judicial authorities.

The complainant is seeking formal legal accountability for Judge _____ unlawful conduct, including the initiation of investigations and appropriate legal proceedings by the relevant authorities. This request encompasses pursuing criminal charges for embezzlement, obstruction of justice, and any additional violations stemming from his misuse of _____ funds and the intimidation of staff. The complainant also seeks disciplinary action by the state bar and judicial oversight bodies, including proceedings for disbarment and removal from judicial office and address the harm caused to the organization and its personnel.
