ORDER

The Complainant alleged a city court judge improperly granted an order of protection when Complainant is a military veteran, while the opposing party has a felony.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Regina L. Nassen and Christopher P. Staring did not participate in the consideration of this matter.

Furthermore, you are already liable in pending civil cases and a criminal
case that have not yet been filed against you in _____ County.
The Cease and Desist orders that you have defiantly ignored will be
presented in legal proceedings to emphasize the facts against you.

Also, _____ was required to vacate Mom's home by yesterday
as per the order to vacate. You must also collect Mom's purse
and deliver any all appropriate contents contained within. The title to
Mom's _____ and the Title to her home that will soon be listed to sell
must also be surrendered.

You will accomplish these requirements IMMEDIATELY or I will have an
armed officer to keep the peace present as I enter the premises of
residency of my mother. Everything can be stored securely at
_____ on _____ with the Manager.

Your eligibility of P.O.A. jurisdiction is virtually impossible given your
criminal rap sheet and continued defiant reputation under the law. You
can now add this Cease and Desist order in electronic form to your
collection by the basis of **PERMANENCE OF NO FURTHER CONTACT**
attempts toward me in any capacity.

If I do receive any P.O.A. documentation that has been newly altered,
and or signifies anyone but me as the sole P.O.A., it will be refused and
returned.

Under the law, a complaint with the courts will be forthcoming to
dismiss any issuance of a new P.O.A. without my signature and reasons
of the attached plus others ".

This concludes yet another and significant statement of defiance by a convicted felon, and was notable as saying on that the petitioner is "proud to be a felon".
